I hereby authorize an investigation of my credit, tenant history, banking and employment for the purposes of renting a house, apartment, or condominium from Property Manager. Further, I hereby authorize Property Manager to obtain a credit report from any credit reporting agency used from time to time by Property Manager, and I understand that the information revealed by such credit report influences the decision to accept or reject my application to rent property. I understand that I have the right to request a copy of said credit report from Property Manager regardless of the decision on my application to rent property.
