# REGULAR MEETING MINUTES CITY COUNCIL OF THE CITY OF BATH, MAINE

Wednesday, March 6, 2013 6:00 PM City Council Chambers, Bath City Hall

Present: Councilors Brackett, Merrill, Paulhus, Lockwood, Eosco, Sinclair, Mitchell, Winglass and Chairman Wyman.

Also in attendance were the City Manager – William Giroux, City Solicitor - Roger Therriault and City Clerk - Mary White.

Chairman Wyman led the Pledge of Allegiance and City Clerk White called the Roll.

Presentation from Access Health regarding banning smoking in City Parks. Councilor Eosco explained that she had asked Access Heath to come and speak to Council to see if Council would be interested in pursuing this issue in the future. Marla Davis, a nurse at Mid Coast Hospital and a member of the Advisory Board for Access Health, asked that the Council consider strengthening the Order that makes the recreation areas smoke-free by extending that ban to the city parks. Linda Christie, Prevention Specialist for Access Health, brought the Council's attention to a packet addressing the issues of smoking and smoke-free areas and the drafting of an ordinance to create a smoke-free zoning in the City Parks. Ms. Christie agreed to provide to Council a list of other municipalities that have this Ordinance in place, tobacco cessation literature and additional draft Ordinances to follow.

The Council's consensus was to address this issue in the future with a focus on the enforcement of the issue.

# \*2) Order: Exercising the Alewife fishing rights at Winnegance Lake to be administered by the Winnegance Alewife Commission as per Harvest Plan.

### **ORDER**

Be It Ordered by the City Council of the City of Bath, Maine, that the Alewife Fishing Rights at Winnegance Lake be operated by the Winnegance Alewife Commission as per Ordinance adopted August 28, 1985, and the municipal rights to take alewives will be sold by the Commission. The Harvest Plan (<u>Condition and Regulations</u>) will be submitted by the Commission setting forth in detail the exact conditions under which alewives may be taken, all in accordance with good conservation practices.

This plan will be submitted to the Department of Marine Resources by the Commission with City of Bath approval.

# \*3) Order: Exercising the Alewife fishing rights at Whiskeag Creek to "Rod and Line" ORDER

Be It Ordered by the City Council of the City of Bath, as follows: that, the taking of alewives at Whiskeag Creek will be restricted to "Rod and Line" only.

5) Rescission Order: 45 Windjammer Way

Chairman Wyman read the following Order:

#### **RESCISSION ORDER**

**WHEREAS,** the City Council of the City of Bath, on December 19, 2012, adopted an Order relating to the condition of the structure at 45 Windjammer Way; and

WHEREAS, at that point in time, the City Council found that the condition of the structure met the definition of a dangerous building, on the basis of a Report by Civil Engineer Helen Watts; and

WHEREAS, the Order based on those findings required the occupants to vacate the premises for safety reasons and due to the danger of collapse of the building during a heavy snow load; and

WHEREAS, since that time, there have been structural repairs to the building in response to, and based on the recommendations in, the Engineer's Report; and

**WHEREAS**, the Engineer and the City's Codes Enforcement Officer have inspected the premises and found the repairs to be adequate to prevent collapse of the structure; and

**WHEREAS**, the structure, in the opinion of the Engineer and City Staff, no longer meets the definition of a dangerous building and that the Order of December 19, 2012 is no longer necessary or appropriate.

**NOW, THEREFORE, BE IT ORDERED** by the City Council of the City of Bath that the Order adopted on December 19, 2012 regarding the condition of the structure at 45 Windjammer Way as a dangerous building, be and hereby is rescinded and the City Council further orders that any pending Codes Enforcement action regarding the building be dismissed.

Councilor Paulhus made a motion to put this item on the floor for discussion. Councilor Mitchell seconded the motion.

6) Proposed Resolution: Supporting Overturning the Supreme Court's decision in Citizens United vs. Federal Election Commission.

Chairman Wyman read the following Resolution:

#### PROPOSED RESOLUTION

The City Council of the City of Bath hereby resolves to support the citizens of Bath, Maine, who reject the U.S. Supreme Court's decision in the case of "Citizens United vs. Federal Election Commission", and the City Council of the City of Bath further resolves to support an amendment to the United States Constitution to firmly establish that money is not free speech and that human beings, not legal entities like corporations, are persons entitled to Constitutional rights.

Councilor Sinclair made a motion to put this item on the floor for discussion. Councilor Mitchell seconded the motion.

Karen Wainberg of 212 Centre Street presented Council with petitions signed by residents urging the Council to approve the Resolution.

The following Bath residents spoke in favor of the Proposed Resolution: Karen Wainberg, Jerry Provencher, Susan Lubner, Adair Delamater, Joanna Johnson, Howard Waxman and Peter Alexander.

Councilor Eosco made a motion to amend the Proposed Resolution first by deleting the wording "the citizens of Bath, Maine, who reject the U.S. Supreme Court's decision in the case of "Citizens United vs. Federal Election Commission", and the City Council of the City of Bath further resolves to support". Her second amendment was to change the word "like" before the word "corporations" to "such as" and her last amendment was to change the word "legal" before the word "entities" to "other".

Councilor Sinclair seconded the motion.
