"From the West Bath town line to Richardson Street, no parking."

"From the West Bath town line to a point 20 feet south of the southerly entrance to the parking lot to the Winnegance Store, no parking.

"From a point 20 feet south of the southerly entrance to the parking lot to the Winnegance Store and running northerly to the driveway to #40 High Street, fifteen-minute parking.

"From the driveway to #40 High Street to Richardson Street, no parking."
