BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BATH THAT THE CODE OF THE CITY OF BATH, ADOPTED FEBRUARY 2, 1977, AND SUBSEQUENTLY AMENDED, BE FURTHER AMENDED AS FOLLOWS:

CHAPTER 17. Vehicles and Traffic Article 5. Operations

Section 17-219. Commercial vehicles in excess of two axles.

All commercial vehicles having in excess of two (2) axles shall be prohibited from using Front Street from Vine Street to Cedar Street, <u>Windjammer Way</u>, Floral Street, <u>Cottage Street</u>. <u>Elsinore Avenue</u>. <u>or Quimby Street</u> except by permission of the police chief, with the exception of service vehicles servicing said streets.

Add: From a point 265 feet north of Oak Street to a point 171 feet north of North Street, no restrictions. From a point 171 feet north of North Street to a point 400 feet north of North Street, no parking. From a point 400 feet north of North Street to termination, no restrictions.

WHEREAS, the City of Bath is desirous of continuing to utilize the services of Pine Tree Waste, Inc. for its City wide solid waste and recycling collection, and

WHEREAS, the new proposed Agreement has a term of two years, and

WHEREAS, the Charter of the City of Bath under the provisions of Section 1102 requires that contracts involving the payment of money out of appropriations for a period of more than one year requires approval by Ordinance,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Bath that the two year Agreement with Pine Tree Waste, Inc. for the collection of solid waste and recyclables within the City of Bath be and hereby is approved and the City Manager is authorized to execute the Agreement on behalf of the City of Bath.
