I. Public Hearing - Resolution for Housing Assessment Planning Grant - 7:01 PM #55

Chairman Hall read the following Resolution:

RESOLUTION

WHEREAS, the City of Bath wishes to apply to the Department of Economic and Community Development for a Small Cities Block Grant to carry out a community development program; and

WHEREAS, the planning process required by Maine Law and the CDBG Program have been complied with, including participation in the planning process by low and moderate income families and individuals and the community has conducted at least one duly advertised public hearing; and,

NOW, THEREFORE, be it resolved by the City Council of the City of Bath that the City Manager:

- 1. Is authorized and directed to submit a Community Development Block Grant Housing Assistance Application to the Department of Economic and Community Development on behalf of the City of Bath substantially in the form presented to this Council;
- 2. Is authorized to make such assurances on behalf of the City of Bath required as part of such applications; and
- 3. Is authorized and directed, upon acceptance of said funds to carry out the duties and responsibilities for implementing said program(s), consistent with the Charter of the City of Bath and the laws and regulations governing planning and implementation of community development programs in the State of Maine.

ORDINANCE SUPLEMENTAL APPROPRIATION -Sewer Utility Capital Reserve

WHEREAS, the City of Bath has significant capital and maintenance requirements for the City's Sewer Utility Fund anticipated in the coming years; and

WHEREAS, additional funds to support the Sewer improvements in connection with Street reconstruction will be necessary; and

WHEREAS, surplus funds in the Sewer Utility Fund Undesignated Fund Balance account, constituting revenue in excess of those estimated in the budget for the current year are available for this purpose; and

WHEREAS, the sum proposed to be appropriated by this Supplemental Appropriation, totaling One Hundred Thousand Dollars (\$ 1 00,000), will not exceed the expenditure limits for the current year pursuant to Section 617 of the Charter of the City of Bath;

NOW THEREFORE, be it ordained by the City Council of the City of Bath that the total sum of One Hundred Thousand Dollars (\$100,000), be and hereby be supplementally appropriated from the Sewer Utility Fund Undesignated Fund Balance (account SUF-2500) to the Sewer Utility Capital Reserve (Account 703-307).

WHEREAS, surplus funds in the General Fund Undesignated Fund Balance account, constituting revenue in excess of those estimated in the budget for the current year are available for this purpose; and

WHEREAS, the sum proposed to be appropriated by this Supplemental Appropriation, totaling Fourteen Thousand Dollars (\$14,000) will not exceed the expenditure limits for the current year pursuant to Section 617 of the Charter of the City of Bath;

NOW THEREFORE, be it ordained by the City Council of the City of Bath that the total sum of Fourteen Thousand Dollars (\$14,000), be and hereby be supplementally appropriated from the General Fund Undesignated Fund Balance (account GF-2500) to the Council Contingency Account (012-402).

WHEREAS, The Fire Department required additional staffing during the year; and

WHEREAS, surplus funds in the General Fund Undesignated Fund Balance account, constituting revenue in excess of those estimated in the budget for the current year are available for this purpose; and

WHEREAS, the sum proposed to be appropriated by this Supplemental Appropriation, totaling Sixty Thousand Dollars (\$60,000) will not exceed the expenditure limits for the current year pursuant to Section 617 of the Charter of the City of Bath;

NOW THEREFORE, be it ordained by the City Council of the City of Bath that the total sum of Sixty Thousand Dollars (\$60,000), be and hereby be supplementally appropriated from the General Fund Undesignated Fund Balance (account GF-2500) to the following Fire Department Accounts:

Regular Pay (Account 100- 102) \$35,000 Sick Pay (Account 100- 109) \$25,000

WHEREAS, The Landfill received additional volume during the year and additional cost related to cover material were required to properly accept this material; and

WHEREAS, revenues in excess of those estimated in the budget were received in the General Fund Landfill Scales Revenue account are available for this purpose; and WHEREAS, the sum proposed to be appropriated by this Supplemental Appropriation, totaling Forty Thousand Dollars (\$40,000) will not exceed the expenditure limits for the current year pursuant to Section 617 of the Charter of the City of Bath;

NOW THEREFORE, be it ordained by the City Council of the City of Bath that the total sum of Forty Thousand Dollars (\$40,000), be and hereby be supplementally appropriated from the General Fund Landfill Scales Revenue Account (REV-5445) to the Solid Waste Applied Material Account (085-214).

WHEREAS, surplus funds in the General Fund Undesignated Fund Balance account, constituting revenue in excess of those estimated in the budget for the current year are available for this purpose; and

WHEREAS, the sum proposed to be appropriated by this Supplemental Appropriation,

totaling One Hundred and Ninety Nine Thousand Dollars (\$199,000) will not exceed the expenditure limits for the current year pursuant to Section 617 of the Charter of the City of Bath;

NOW THEREFORE, be it ordained by the City Council of the City of Bath that the total sum of One Hundred and Ninety Nine Thousand Dollars (\$199,000), be and hereby be supplementally appropriated from the General Fund Undesignated Fund Balance (account GF-2500) to the following Capital Project Accounts:

NOW, THEREFORE, BE IT ORDERED by the City Council of the City of Bath that the wage scale now in effect be adjusted by adding 3.75% to the wage levels on the scale, effective July 1, 2000.

WHEREAS, the Deed from the City of Bath to the Bath Area Family YMCA, dated April 7, 2000, and recorded in the Sagadahoc County Registry of Deeds in Book 1763, Page 77, contains a provision that restricts the use of the property to the erection, maintenance and utilization of a facility for recreational purposes of the Bath Area Family YMCA and no other purpose, and

WHEREAS, this provision is an impediment to the Bath Area Family YMCA acquiring financing for completion of its new facility.

NOW, THEREFORE, BE IT ORDERED by the City Council of the City of Bath that the provision be modified in accordance with the Municipal Quit-Claim Deed attached hereto and that the City Manager be authorized to execute the said Quit-Claim Deed.

Motion by Councilor Williams, seconded by Councilor Reed to put this Order on the floor for discussion.

William Haggett, YMCA Building Committee Chairman, spoke to Council stating that this modified deed was agreeable to the Committee and asked for Council support.
