ORDER APPROVING WAGE REOPENER

WHEREAS, the current Bargaining Agreement between the City of Bath and the Bargaining Unit representing the Wastewater Treatment Plant/Public Works Department/Cemeteries and Parks Department employees requires that the parties meet and bargain a new wage scale for the third year of the Contract beginning July 1, 2001, and

WHEREAS, the parties have agreed to a wage adjustment for the last year of the Bargaining Agreement and a one-time adjustment in vacation time,

NOW, THEREFORE, BE IT ORDERED by the City Council of the City of Bath that the wage scales in effect for the fiscal year beginning July 1, 2000 and running through June 30, 2001 be amended by adding 1% to all wages levels on said scales, effective July 1, 2001 in accordance with the wage scales attached hereto as Schedule A and Schedule B. In addition, the City shall grant to all Bargaining Unit employees, only for the fiscal year beginning July 1, 2001 and running through June 30, 2002, additional vacation time of Forty (40) hours per employee.
