# CHARTER AMENDMENT QUESTION NO.2

# "SHALL THE MUNICIPALITY APPROVE THE CHARTER AMENDMENT REPRINTED BELOW?" YES NO

# SUMMARY:

### DELETE:

To provide more flexibility in establishing the amount of individual installments of bond repayment, to provide for the ability to prepay bond indebtedness, and to allow for existing bonded indebtedness to be refinanced.

Sec. 807. Annual Installments; Term, which reads as follows:

All serial bonds or notes issued pursuant to this Chapter shall be payable in annual installments which shall be substantially equal in amount or shall be so arranged that no installment shall be less than the amount of any installment payable in a subsequent year and the terms of such bonds or notes shall not exceed 30 years.

Replace with the following:

REPRINT: Sec. 807. Installment, Prepayment, Term.

Bonds, notes and other securities issued pursuant to this Chapter may be in serial form payable in annual installments, which need not be equal, the total amount of which shall extinguish the entire debt at maturity pursuant to the requirements of 30-A M.R.S.A. Section 5772(3). Any bond, note or security may be prepaid in whole or in part at any time as may be permitted in accordance with the terms and conditions of the borrowing of the original bond, note or security. The term of such bonds, notes or securities shall not exceed 30 years from the date that they are issued.

Add new Sec. 813. Refinancing.

Bonds, notes or securities may be issued in accordance with the provisions of this Chapter VIII of the Charter of the City of Bath and after approval by the City Council by Ordinance, in order to refinance any outstanding bond, note or security or other indebtedness of the City. This authority to refinance any outstanding bonds, notes or securities of the City which have been approved at public referendum, shall not require additional voter approval of the new indebtedness and repayment shall continue to be exempt under the provisions of Sec. 617(2) of this Charter, which establishes limitations on municipal expenditures.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Bath that the Zoning Map of the City of Bath, dated July 19, 2000, be and hereby is amended in accordance with the Sketch Plan attached hereto and made a part hereof. This change shall be incorporated into and be part of the official Zoning Map of the City of Bath. The specific adjustment is:

Changing the zoning on a parcel of land on the east side of Oak Grove Avenue (Tax Map 19, Lot
 from R1 Zone to R2 Zone.
