- III. City Clerk White put nominations for the position of Council Chairman on the floor. Councilor Blake made nomination of John James IV for the position of Chairman. Seeing no other nominations Councilor Hall made a motion that nominations cease, second by Councilor Rogers. Councilor John James IV was unanimously elected Council Chairman to serve to the first Wednesday of December 2003.
- IV. Chairman James asked for nominations for the position of Vice-Chairman of the City Council. Nomination of Halcyon Blake for the position of Vice-Chairman was made by Councilor Hall. There were no other nominations. Councilor James asked for a motion from the floor for the casting of a unanimous ballot from the clerk for Councilor Blake. Motion by Councilor Hall, second by Councilor Rogers for the clerk to cast the unanimous ballot. All were in favor. Councilor Blake was unanimously elected as Vice-Chairman to serve to the first Wednesday of December 2003.
