Al Smith, Community Development Director, addressed Council regarding the City of Bath's Public Service Grant that will be presented to the State. The Community Development Committee chose "Maine Lead Action Project" to support. Mr. Smith then gave an overview of the program and how it would relate to what the CDBG program is already doing within the City of Bath.

II. Public Hearing - Ordinance - Chapter 17. Vehicles and Traffic, Article 8. Penalties, Section 17-**351 Penalties for Parking Violations (second passage) -** 7:07 PM #191

CHAPTER 17. VEHICLES AND TRAFFIC

Article 8. Penalties

Sec. 17-351. Penalties for parking violations.

(c) Payment of waiver fee....

Add:

2 (Except Downtown Business District)				
2A. Overtime Parking - Downtown Business District Only

b.	The second violation within a quarter	\$5.00

Delete (e) Waiver of Overtime Parking Penalty - Downtown Business District in its entirety.

Replace with the following:

(e) Warning for Overtime Parking - Downtown Business District: For the first overtime parking violation occurring in the Downtown Business District, as defined below, a warning shall be issued. Any subsequent violation occurring after the warning during any quarter, also as defined below, shall be subject to the waiver fee as set forth in Subsection 2A under Subsection (c) of this Section (17-351). The Downtown Business District shall be defined as that area within the following boundaries: south of Oak Street, west of Kennebec River, north of Vine Street, and east of Washington Street. Quarter shall be defined as any of the time frames inclusive from: January through March, April through June, July through September, and October through December.

Motion by Councilor Blake, second by Councilor Rogers to put this Ordinance on the floor for discussion and consideration.

Police Chief Pete Lizanecz explained the reasons this Ordinance was needed-one, being that it would be easier to administer on a quarterly basis and secondly, the ceasing of habitual monthly violations would be eliminated.

XII. Resolution: Supporting Local Tax Options 8:00 PM #1808

Chairman Wyman read the following Resolution:

RESOLUTION

SUPPORTING LOCAL OPTION TAXES

WHEREAS, the Maine State Legislature has before it proposals allowing communities the ability to vote on a local option tax, and

WHEREAS, the fundamental purpose of the general legislation at hand is to allow local governments to ask its citizens to vote on issues relating to self taxation, and

WHEREAS, the purpose of local option taxes in general is to allow Maine Municipalities to raise monies to fund capitol projects and/or special purpose projects from sources other than the local property tax, and

WHEREAS, Municipalities have been restricted to the local property taxes as a primary source of revenue to fund municipal capital activities, and

WHEREAS, the burden on the local taxpayer represented by the local property tax is disproportionately high in relation to other broad based taxes such as the State's sales tax and State's income tax, and

WHEREAS, the cost of municipal services has been significantly increased beyond normal increases driven by adjustments in the cost of living, due to unfunded State and Federal mandates and disproportionately large increases in fixed expenses such as the County tax and health insurance costs, and

WHEREAS, the ability of the local property owners to fund these municipal expenditures has reached saturation, with the prospects of no local property tax relief in terms of other revenues sources, and

WHEREAS, the local property tax in and of itself represents a regressive disproportionate tax unrelated in many instances to the ability to pay,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Bath that the City Council does hereby endorse and support legislation designed to allow local government to ask its citizens if they wish to allow certain local option sales tax methods that are designed to reduce or offset the reliance of the local property taxes and which will have the effect of shifting a portion of the tax burden to a more progressive tax system.

Motion by Councilor Reed, second by Councilor James to put this Resolution on the floor for discussion and consideration.

Motion by Councilor Hall, second by Councilor Banks to amend the Resolution by deleting Paragraph #3 in its entirety.

Vote on Amendment:

Chairman Wyman called for a vote by the raising of hands.
