#### **REGULAR MEETING MINUTES**

City Council of the City of Bath, Maine Wednesday, December 7, 2005 7:30pm City Council Chambers, Bath City Hall

Present: Councilors Hinds, Omo, Quimby, Blake, Hart, Verville, Pagurko, Winglass and Chairman Wyman.

Also in attendance was the Acting City Manager – Paul Mateosian, City Solicitor - Roger Therriault and City Clerk - Mary White.

Chairman Wyman led the Pledge of Allegiance and City Clerk White called the Roll.

Chairman Wyman read a certificate of appreciation to Henry Mann for his participation in the "Candidates' Night" program.

Mr. David Smith of the Greater Bath Elder out reach Program gave a history of the program. He stated that the program has been in operation for 2 ½ years and has been addressing concerns of the elderly, such as safety, transportation and financial. Mr. Smith introduced Kathy Chappini, Program Coordinator.

Ms. Chappini stated that the program has 15 volunteers serving one on one with a resident that needs assistance. She explained that the volunteers are putting in over 100 hours of care to the elderly a month in Bath.

WHEREAS, the double axle dump truck previously utilized by the Public Works Department has become inoperable and will not pass inspection, and

WHEREAS, this vehicle was not scheduled for replacement in this fiscal year under the City of Bath Public Works Capital Improvement and Vehicle Replacement Plan, and

WHEREAS, the Public Works has sold by bid, in order to raise additional funds to support the truck replacement surplus equipment consisting of a 1988 triaxle dump truck and a 1987 single axle plow truck and has received bids for \$12,000.00 for the triaxle and \$1,500.00 for the plow truck, and

WHEREAS, the total of the bids, \$13,500.00, constitutes revenue in excess of those estimated in the Budget for the current year and are available for the purpose of supplemental appropriation, and

WHEREAS, the sum proposed to be appropriated by this Supplemental Appropriation, totaling \$13,500.00 will not exceed the expenditure limits for the current year pursuant to Section 617 of the Charter of the City of Bath.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Bath that the total sum of \$13,500.00 be and hereby is supplementally appropriated to the Public Works Capital Replacement Reserves Account (Account PW05-550).

John Bliss of 32 Oak Street owner of the property. Mr. Bliss addressed Council stating that Bath needs to make a choice between a quiet small town set of values with privatized parking, traffic and strict separation of land uses and building types or an urban set of values with wider assortment of building types a more open public access to the municipality to help support a more lively set of life styles. He asked Council to consider the benefits of the extended tax base this change would make possible for the city.

Jayne Palmer of 300 Front Street spoke against this Ordinance bring attention to the fact that the Sewall House has historically been a used a residence. She asked Council to keep in mind what a change like this would mean to the neighborhood.

Elizabeth Knowlton of 969 Washington Street spoke against the change but had no object to what the R1 zoning would allow that is now in place.

Patricia Sample of 16 Winter Street spoke against the change due to parking issues that it would cause.

Jim Upham, City Planner, explained the details of the changes that were proposed and the Planning Board's decision not to recommend the ordinance change.

#### **Item 15 – Order – Approving Second Transfer of South End Park Property**

### ORDER APPROVING SECOND TRANSFER OF SOUTH END PARK PROPERTY

WHEREAS, the Bath Iron Works is required to transfer to the City of Bath the premises known as the South End Storage Facility for purposes of establishing a public park, as one of the conditions of approval for the Land Level Facility at Bath Iron Works as issued by the Maine Department of Environmental Protection, and

WHEREAS, the City has been advised that the property has been remediate to the satisfaction of the Maine Department of Environmental Protection and issues relating to certain hazardous substances on site have been resolved, and

WHEREAS, the southerly 6-acre portion of the premises has been conveyed to the City and currently operates as a City park, and

WHEREAS, the northerly 3.66 acres  $\pm$  has now, upon information and belief, been remediated and is in a status ready for conveyance, and

WHEREAS, Declaration of Environmental Covenant has been executed on November 15, 2005 by the Bath Iron Works, said Declaration to be recorded in the Sagadahoc County Registry of Deeds (executed copy attached\*), and

WHEREAS, a Commissioner's Certificate of Completion of Remedial Actions Under a Voluntary Response Action Plan has been drafted and submitted to the Commissioner of the Maine Department of Environmental Protection and is currently under consideration (proposed copy attached), and

WHEREAS, the premises have been surveyed and a survey description has been developed and is attached to the Declaration of Covenants as Exhibit A.

NOW, THEREFORE, BE IT ORDERED by the City Council of the City of Bath that the transfer of the premises described as Exhibit A to the Declaration of Environmental Covenants, being the northerly 3.66± acres of the property formerly known as the South End Storage Facility, be and hereby is accepted and the City Manager is authorized, on behalf of the City, to accept transfer documents in a form acceptable to the City Manager, and to execute any and all documents required to consummate this transaction. The transfer is subject to the prior condition that Commissioner's Certificate be executed by the Commissioner of the Maine Department of Environmental Protection, in a form acceptable to the City of Bath, and recorded in the Sagadahoc County Registry of Deeds and that a recordable Plan be produced for recording in said Registry.

#### G. Petitions & Communications: 9:16 PM

Councilor Hart brought to the Council's attention that he had communications regarding concerns over the new Morse High School open lunch policy. Councilor Quimby stated that the school will be monitoring this program closely and would appreciate any comments from the surrounding area residents. Councilor Hart stated that he had received a letter from a resident on Andrews Road regarding the sighting of hazardous waste (batteries) on North Street. Councilor Hart has contacted the City Codes Officer and he will take care of the situation.

Councilor Winglass addressed Council regarding a citizens' letter stating concerns at an intersection on Whiskeag Road and North Bath Road. He would like to see the City Manager and the Police Chief look into these concerns. Paul Mateosian explained that he had discussed this issue with the Public Works Director and the Police Chief and they suggested that a traffic study would be the best solution to the situation.

Councilor Wyman reported on a communications from residents in North Bath regarding sewage backups leaving raw sewage on the ground. Mr. Mateosian stated that the Public Works Director was addressing this problem, but it was a difficult situation to fix as it was an instance of the connections being overtaxed by the high levels of rainwater recently experienced. Regarding the same subject of water overrun, Councilor Omo related some concerns on Richardson Street with a safety issue of icing.

Councilor Blake stated that the Comprehensive Plan Committee is addressing this issue in their meetings. Councilor Winglass suggested a look at the tipping fees might help this situation.
