REGULAR MEETING MINUTES City Council of the City of Bath, Maine Wednesday, February 2, 2005 6:00 pm City Council Chambers, Bath City Hall

Present: Councilors Hinds, Quimby, Blake, Wyman, Hart, Daigle, Pagurko, Mitchell and Chairman Winglass

Also in attendance were the City Manager - John Bubier, City Solicitor - Roger Therriault and City Clerk - Mary White.

Jamie Silvestri, Coordinator for the Art Works program, updated the Council on some of the activities that are going on and planned for Spring. These classes are for students from 5 to adult and include painting, calligraphy, movement and performing arts. The program focuses on promoting creativity and the arts in the community. The new component to the program is the Art Van, which brings the art classes to the Hyde Park, Lambert Park and Maritime Apartments areas of the City.

Katrina Van Dusen of MCBDP introduced Paul Godfrey, a consultant for the Department of Transportation. Mr. Godfrey gave an update on the Gateway One project. He stated that the project would be a collaboration of transportation and land use planning. The steering committee will be made up of representatives from 20 communities from Brunswick to Stockton Springs, the MDOT, the Federal Highway and the State Planning Office. Mr. Godfrey stated that there were going to be two phases to this project.

Some identified concerns regarding Bath are speeding a" Saugus image" and the impact of the growing corridor on the community.

Mr. Godfrey gave an overview of Phase I which consists of a findings and fact inventory, a multi-town public meeting and would end with the signing of a Memorandum of Understanding by 15 of the 20 communities. Phase II will follow once these tasks are completed and will consist of up to date mapping, detailed analysis of travel patterns, development of alternative transportation and landuse solutions, prioritizing MDOT projects, a collaborative corridor wide solution, development of inter-local agreement and the development of an on-going State/Local process.

If the Planning Director makes a preliminary determination that the application is complete and it is a site plan that must be reviewed by the Planning Board, it is placed on the agenda of the next available Planning Board meeting. If the Planning Director makes a preliminary determination that the application is not complete, he/she must notify the applicant in writing and must list the materials or information that must be submitted to complete the application. The applicant may appeal the Planning Director's determination in writing; the application then will be placed on the agenda of the next available Planning Board

meeting.

- 2. Action taken by the Planning Director with respect to reviewing a site-plan application does not result in an application being deemed pending for the purposes of 1 M.R.S.A. Section 302.
- 3. The Planning Director may, if the City's staff is not available or qualified because of the complexity or magnitude of the proposed development to review the plans and supporting materials and after notification to and at the expense of the applicant, employ 1 or more independent consultants to review the plans and supporting materials. The estimated costs of such consultant must be deposited with the City Treasurer prior to employing the independent consultant. If the cost of the review exceeds the amount deposited, the applicant must deposit additional funds with the City Treasurer before Site Plan Approval may be granted. Any money not spent must be reimbursed to the applicant.

Councilor Hart brought to the attention of the Council the following letter from a resident in his ward.

Hello Jack,

My name is Rex J. Harrison and I'm one of your constituents in Ward 5. Will you please take the following suggestion to the City Counsel for consideration?

I'm aware there is a lot of activity locally and on the state level dealing with property taxes. My suggestion is to request that the City Counsel review the various exemptions that apply to the assessed property values. For example, if my property was previously assessed last year for \$88,000, with a Homestead Exemption of \$6,500 and Miscellaneous VA Disability Exemption of \$5,000, I would pay property taxes on \$76,500. If however, the property was reassessed this year for say \$130,000 and the exemptions stayed the same, I would be realizing an increase in my property taxes based on both the newly assessed value AND because the exemptions did not increase proportionately to the rate of increase of the assessed value.

I don't know what other types of exemptions there are besides the two I previously mentioned, but this is a situation that could potentially affect many property owners in Bath, and the rest of the state for that matter.

If the city counsel is not the correct forum that would consider such a suggestion, then I further request the counsel forward my suggestion to the proper authority for consideration or let me know the correct avenue I should be taking.

John Bubier, City Manager, explained that the increase would result in a decrease in the actual rate, which calculates into approximately what the payment was in the previous year. He stated that the homestead exemption would expand to \$13,000 this will result in a 10% increase in Mr. Harrison's homestead exemption so he should do well.

Councilor Wyman shared a list of Water Districts in the State of Maine showing that Bath Water District ranks 24th in the rates charged. He gave the Council a copy of the following letter from Trevor Hunt, Bath Water District Superintendent, explaining the fire hydrant issue.

Bernie;

I just wanted to follow up on your e-mail of yesterday regarding the hydrants.

I looked back in the files and we have a 1978 Memorandum of Agreement with the City which states; "It shall be the joint responsibility of the City of Bath and the Bath Water District through a cooperative effort under the direction of the Fire Chief of the City of Bath to remove snow and ice from fire hydrants as designated by prevailing weather conditions. In furtherance of this cooperative effort, the Bath Water District further agrees to provide the equipment, to wit: a backhoe and an operator therefore. The City of Bath in furtherance of this cooperative effort agrees to provide additional personnel as may be needed."

In April of 1978 a follow up letter from the BWD Superintendent to Larry Cilley, City Manager states: "The District would like to reaffirm its position relative to snow removal at hydrants. In the interests of community cooperation and public safety, the District will continue to assist the City, under the direction of the Fire Chief, in the removal of snow at hydrants, when and if its personnel and equipment are available. The foregoing is a continuation of past policy and practice."

A 1982 Memorandum of Understanding of November 1882 states: "Snow removal around hydrants will continue to be accomplished by a joint effort between the City of Bath and Bath Water District with the City's Fire Department acting as team leader. The Water District will furnish a bucket loader and operator.

These documents are available if you would like copies.

All hydrants in West Bath, Woolwich and East Brunswick are cleared (and have been cleared) by the respective Fire Departments.

Our efforts in November of 2004 to work with the Fire Department and to prepare for this years storms were met with no response. We had hoped to initiate an "Adopt a Hydrant" program in which residents and businesses helped us with this task, as public safety is actually everyone's responsibility.

Our crew have been extremely busy with 7 leaks so far, (including one today on upper High Street), numerous freeze ups and of course our meter change out program which requires appointments with customers. We have been and are always prepared to honor our above agreement to assist with snow removal but with our very limited resources we need the Fire Department to take the initiative.

Hope that helps explain our position, I am very concerned that there are many hydrants completely buried and possibly more snow to come.

Councilor Hart reported that the SCLC Committee at Morse High is instituting a "Student of the Quarter" program where the student chosen receives a month's free parking privileges.

Regarding the Community Policing Committee he reported that Reverend Greg Vinson was now training chaplains at the Police Academy, Chief Lizanecz has been appointed to the Advisory Board of the Maine Community Policing Institute and the Police Department has started a "Project Good Morning" for elderly and disabled residents where the resident registers with the police department and calls in each morning. If the resident doesn't call in, the Police Department checks on the person to make sure they are alright.

Council Daigle reported that he had attended the Fisher Mitchell PTA spaghetti supper and skating party and said a wonderful time had by all the attended.

Councilor Quimby stated that he had gotten many good reviews on the window installed at the skating hut at Goddard's Pond.

Council Wyman commended Councilor Quimby on his volunteering to teach classes on rough plumbing for the Vocational students at Morse.

Chairman Winglass met with Dr. Patten regarding getting a new leader for the Shariki program. They met with Maggie Allen, Board of Education Chairman, to discuss where the program's future might be going.

He also reported on the Finance Committee meeting. The Committee was updated on the City's financial status to this point and he said the figures appear to be right on target. He stated that there is a problem with ambulance fee structure that needs to be addressed. The Committee will be meeting quarterly.

Chairman Winglass next reported on the Southend Park Committee. He stated that he had resigned as Chairman of that committee and Tom Hoerth had been chosen to replace him. They discussed BIW starting Phase II of the project and the application for a landscaping grant.

Chairman Winglass reported on the Community Reads Program. The book being used this time is called <u>The Kite Runner</u>.
