# **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BATH THAT THE LAND USE CODE OF THE CITY OF BATH ADOPTED JULY 19,2000, AND SUBSEQUENTLY AMENDED, BE HEREBY FURTHER AMENDED AS FOLLOWS:

Amend Article 2 -Definitions, Section 2.02, as follows:

Street: For the purpose of determining frontage and access requirements only; a way established or maintained under public authority; a private way meeting the standards contained in Section 13.14. B. 2. (e), approved by the Planning Board, and recorded at the Registry of Deeds; a way shown on a plan of a subdivision duly approved by the Planning Board; a way shown on a plan recorded in the Registry of Deeds prior to September 23, 1971; a way that is existing at the date of adoption of this Section, which meets the standards contained in Section 13.14. B. 2. (e).

Street Bottle-neck That segment of a dead-end street system, which must serve as both ingress and egress.

Street, Continuing A street having two ends: each end connecting with a different continuing street or loop street.

Street, Loop A street that has two ends, each end connecting with the same the connections are less than 500 feet apart the street is considered a dead-end street system.

3) Ordinance: LUC Article 11 – Section 11.36 Manufacturing, Processing, Creation, Renovation, or Assembling of Goods, Merchandise, or Equipment in the downtown Commercial District (second passage) #1272

# **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BATH THAT THE LAND USE CODE OF THE CITY OF BATH ADOPTED JULY 19, 2000, AND SUBSEQUENTLY AMENDED, BE HEREBY FURTHER AMENDED AS FOLLOWS:

Amend Article 11, Section 11.36, as follows:

# SECTION 11.36 MANUFACTURING, PROCESSING, CREATING, RENOVATING, OR ASSEMBLING OF GOODS, MERCHANDISE, OR EQUIPMENT IN THE DOWNTOWN COMMERCIAL DISTRICT

This Standard applies to land Use category 4.1 if located in the C1 zoning district.

A. May not be located on the ground floor unless on the ground floor at least 30 percent of the gross floor area of the use is devoted to, available to, and physically arranged to accommodate walk-in, retail sales of the product of the business.

B. Notwithstanding A, above. a Category 4.1 use may be located on the ground floor of a mixed use building, which must include a Category 2 use, a Category 3 use, or a Category 10.1 use, provided the Category 4.1 use occupies no more than 50% of the around floor and does not occupy more of the storefront than is necessary for safe personal egress. The *storefront* means that portion of the building that abuts a street, a City owned parking lot or the Kennebec River and is 15 feet in depth from that street, City owned parking lot or Kennebec River.

C. The <u>non-Category 4.1</u> use of the <u>building</u> must be physically separated from the <u>Category 4.1 use</u> of the building.

D. May only be conducted in a building, which existed on July 19, 2000.

Jim Upham, City Planner, explained an amendment that needed to be made to the Ordinance.

Motion by Councilor Quimby, second by Councilor Mitchell to amend Paragraph B, last sentence to read "The *storefront* means that portion of the building that abuts a street, a City owned parking lot or the Kennebec River and is <u>at least</u> 15 feet in depth from that street, City owned parking lot or Kennebec River."

# **Item 7 A Family for ME Proclamation #1826**

#### **PROCLAMATION**

WHEREAS, approximately 2,699 children in Maine are in the care of the Department of Human Services; and

WHEREAS, nearly all of these children have special needs because of physical, mental or emotional disabilities, because they must be placed with other siblings, because they are children of color or because they are school-aged; and

WHEREAS, these children need extra patience and support to help them overcome past and present hardships; and

WHEREAS, many of these children are cared for by one of 1,251 licensed foster families; and

WHEREAS, approximately 270 children are currently in foster homes where they expect to be adopted; and

WHEREAS, families are able and willing to care for children who have special needs; and

WHEREAS, in 2004, 294 children who have special needs were placed into adoptive families in Maine, and

WHEREAS, it is important to stress that a disability, low income or being single does not disqualify individuals from adopting; and

WHEREAS, approximately 216 children are waiting for adoptive families currently in the State of Maine, and

WHEREAS, children waiting for adoptive parents, and families who are caring for these children or have decided to adopt these children require and deserve public and agency support.

NOW, THEREFORE, BE IT RESOLVED, THAT WE, the Bath City Council of Bath, Maine, do hereby declare May 2005 as Foster Care Awareness Month in Bath, Maine. In recognition of this event, we encourage community agencies, religious organizations, businesses and others to celebrate foster care, to honor families that grow through foster care, to further an awareness of the changes and issues in foster care and to focus attention on those who live in the shadow of an uncertain future while they await "forever families".

WHEREAS, Sections 14-28, 14-30, 14-51(b), 14-52(a), and 14-54 of the Code of the City of Bath specifies that the City Council from time to time shall establish by Resolution, upon recommendation from the City Manager, a schedule of rates for the sewer system fees and use charges together with surcharges which may be applicable, as well as special assessments, and

WHEREAS, it is apparent that an increase in the rate structure is necessary in order to fund the waste water treatment system, and

WHEREAS, such an increase is recommended by the City Manager,

NOW THEREFORE be it resolved by the City Council of the City of Bath, pursuant to their authority under the Code of the City of Bath, that the following rate structure, listed in the attached table, be and hereby is adopted for all listed fees, charges, and special assessments, beginning July 1, 2005, and continuing until further Resolution of the Council:
