<u>Item 2 Ordinance: Curdinance: LUC Amendment Article 16, Section 16.12 – 15 Congress Avenue</u> Contract Zone (first passage) #329

Chairman Winglass read the following Ordinance:

ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL, OF THE CITY OF BATH THAT THE LAND USE CODE OF THE CITY OF BATH ADOPTED JULY 19, 2000, AND SUBSEQUENTLY AMENDED, BE HEREBY FURTHER AMENDED AS FOLLOWS:

Amend Article 16, by adding Section 16.12, as follows: SECTION 16.12 -15 CONGRESS AVENUE CONTRACT ZONE

A. District Designation

The property designated for this contract zoning amendment is Lot 2 on City of Bath Tax Map 29, dated April 1, 2005.

B. Findings

The property is located in the Route 1 Commercial Contract (C4) District. The City Council makes the following additional specific findings:

1. The project consists of expanding the paved area on the front portion of the parking lot and relocating the dumpster to this expanded paved area.

- 2. The project is consistent with the mandatory conditions set forth in Land Use Code Section 8.20 paragraph D, 1.
- 3. The applicant is proposing to make aesthetic improvements to the front of the site, which are not normally required of the Land Use Code.
- C. Zoning Provisions Affected

This contract zoning amendment is intended to change the front Yard Area requirements pursuant to Section 8.10 to the Yard Areas as approved in the Site Plan Approval granted to Douglas Rink (Bath Animal Hospital), by the Bath Planning Board on August 2, 2005.

D. Conditions of Approval

The approval is subject to all conditions of approval, which are part of the Site Plan Approval, granted to Douglas Rink (Bath Animal Hospital), by the Planning Board on August 2, 2005.

Jim Upham, City Planner, explained the owner's plans for the lot and the reason the Ordinance change needed to take place.
