## E. Time Devoted to Residents to Address the City Council: 6:14 PM

Kay Pierson of 25 Springview Lane spoke to Council regarding Contract Rezoning. She referenced a project, proposed the renovation of the Stinson Cannery in Belfast, Maine into a multi-use facility including condos, marine and mixed use retail but under strict guidelines. This initiated Belfast's Contract Rezoning process. She shared the Contract Zoning document that came from this process. Ms. Pierson asked that Council research, address and prioritize as a goal the City's process of Contract Rezoning for the betterment of the community and waterfront as a whole.

Betsy Fear of 944 Middle Street asked that the City think about looking at the process of Contract Rezoning because the public sometimes feels like they are left out. She said that even though they do have the opportunity to speak, it sometimes seems like things are approved based on some of the information the public doesn't have total access to, so maybe the Council could look at the process again with these considerations in mind.

Section 13-34. Nonpayment

Add to the text below the underlined language:

Failure to pay any fee assessed hereunder shall constitute a violation of this Section and shall result in refusal of access to the facility and prohibition of any additional dumping of material or other use of the facility. In addition, any fee that remains unpaid thirty (30) days after the date of billing, will be assessed interest at the same rate as assessed against unpaid ad valorem property taxes as set annually by Council in accordance with Section 7-101 of the Code.
