## **ORDER**

BE IT ORDERED BY THE CITY COUNCIL OF THE CITY OF BATH THAT THE LEASE TO TERRI CROCKER FOR USE OF A PORTION OF THE LAMBERT PARK COMMUNITY CENTER FOR THE CONDUCT OF A DAY CARE PROGRAM AND A BEFORE/AFTER SCHOOL PROGRAM, FOR THE LIMITED HOURS AND DAYS, SUBSTANTIALLY IN ACCORDANCE WITH TERMS AND CONDITIONS OF THE LEASE ATTACHED HERETO, BE AND HEREBY IS APPROVED AND THE CITY MANAGER IS AUTHORIZED TO EXECUTE SAID LEASE ON BEHALF OF THE CITY OF BATH.

Councilor Hinds stated that the lease had unanimous support of the Recreation Commission.

City Manager, William Giroux, explained details of the lease, hours of operation and expenses that would be covered by the leasee.

Motion by Councilor Quimby, second by Councilor Pagurko to waive the rules and allow William Edgett of 2 Edgett Street to speak to Council. All in favor.

Mr. Edgett addressed the following issues, which were being experienced due to the construction happening on Edgett Street:

- Problems with cutting of trees
- Construction:
  - No snow fencing protection for trees, as promised
  - Construction trucks are using Edgett Street not the Congress Avenue entrance that was supposed to be used
  - Contractor using neighbors' property without permission
  - Excessive blasting noise
  - No measures being taken to control excessive road dust from vehicles traveling roadway

City Manager, William Giroux, explained that the City had been made aware of these issues and was trying to address them with the Contractor as this time.

The meeting adjourned at 6:25 PM with a motion from Councilor Hinds and a second from Councilor Pagurko. All in favor.
