I. PUBLIC HEARING: CDBG Business Assistance Grant regarding Gagne Foods of Bath 6:00PM

Chairman Wyman read the following Notice.

Public Hearing Notice City of Bath For Two CDBG Projects

The City of Bath City Council will hold two Public Hearings on Wednesday. June 11, 2008 at 6:01 P.M. on the third floor of City Hall in the City Council Chambers to report on the progress and receive questions regarding two CDBG Business Assistance Grants and a Development Fund Loan to assist two local businesses. The projects include: \$400,000 to Gagne Foods of Bath for the purchases of new equipment to expand the business and \$150,000 to Marnee's Cookies for the purchase of equipment and operating capital. Together, both businesses are creating at least 24 full-time jobs. Public comments will be solicited at these Hearings and will be submitted to the Department of Economic and Community Development Office of Community Development. All persons wishing to make comments or ask questions about these projects are invited to attend this Public Hearing and may also contact the City's CD Office at 55 Front Street, Bath ME 04530 or call 443-8372.

Chairman Wyman opened the public hearing.

Al Smith, CDBG Coordinator, stated this was part of the grant process to give and receive comments regarding this project. Mr. Smith said this was a 50/50 match of funding and the business has met its requirements.

Seeing no other comments Chairman Wyman closed the public hearing.

RESOLVED, The Bath City Council hereby supports the grant application for *Preserve America* funds to assist the completion of *Historical Markers Plus*.

RESOLVED, that the City of Bath will protect and celebrate our heritage, use our historic assets for economic development and community revitalization, and encourage people to experience and appreciate local historic resources through education and heritage tourism programs.
