I. ORDER – Approving Bid and Contract for the High Street Project 6:01 pm

Madame Chair Eosco read the following Order:

ORDER APPROVING BID AND CONTRACT FOR THE HIGH STREET PROJECT

BE IT HEREBY ORDERED BY THE CITY COUNCIL OF THE CITY OF BATH, THAT THE BID OF HARRY C. CROOKER AND SONS FOR THE HIGH STREET REHABILITATION PROJECT IN THE AMOUNT OF \$1,230,490 IS ACCEPTED, IT BEING THE LOWEST QUALIFIED BID SUBMITTED, AND A CONTRACT BY AND BETWEEN THE CITY OF BATH AND HARRY C. CROOKER AND SONS IS HEREBY APPROVED AND THE MANAGER IS AUTHORIZED TO EXECUTE THE CONTRACT AND ANY OTHER DOCUMENTS NECESSARY TO ITS IMPLEMENTATION ON BEHALF OF THE CITY OF BATH. THE PROJECT SHALL BE FUNDED BY THE NOVEMBER 2013 STREET BOND APPROVED BY THE VOTERS AND BY A MUNICIPAL INITIATIVE GRANT LOAN FROM THE MAINE DEPARTMENT OF TRANSPORTATION.

Councilor Wyman made a motion to put the Order on the floor for discussion. Councilor Lockwood seconded the motion.

Public Works Director Peter Owen explained the bid process and gave an overview of the timeline and the project. He stated that he recommended passage as it was a very good price.
