These include a \$60,000 Public Infrastructure Grant to reduce sewer overflows on Willow Street through infrastructure improvements and a \$500,000 Housing Assistance Grant to fund the development of up to eleven (11) new affordable housing units on Tarbox Street. 6:01 PM

IV. Order: Authorizing Purchase - Crooker Construction LLC for preparing the McMann Athletic Track Area for Replacement. 6:09 PM

Councilor Mitchell made a motion to waive the reading of the Order. Councilor Brackett seconded the motion. All were in favor of the waiving motion.

ORDER AUTHORIZING PURCHASE

WHEREAS, the track surface at the McMann athletic facility has significantly deteriorated, and now is in need of replacement; and

WHEREAS, to avoid issues with bonding of old asphalt and new asphalt at the track facility, utilization of the prior contractor, Crooker Construction, LLC, to prepare the track area for resurfacing is of significant benefit to the City, which benefit can only be provided by Crooker Construction, LLC; and

WHEREAS, pursuant to Section 7-110 of the Ordinances of the City of Bath, when the nature of a purchase renders the competitive bidding process ineffective by virtue of a unique or complex situation, selection of a single supplier is authorized; and

WHEREAS, Crooker Construction, LLC, has performed most of the site work at the McMann athletic complex, has the prior engineering installation specifications, constructed the previous track underlayment, and can avoid issues with asphalt bonding; and

WHEREAS, the proposal amount for the project from Crooker Construction, LLC is \$111,068.70 and is within budget; and

WHEREAS, selection of Crooker Construction, LLC to perform the necessary work would be appropriate under the circumstances.

NOW, THEREFORE, BE IT ORDERED by the City Council of the City of Bath that Crooker Construction, LLC be awarded the contract for preparing the track area for resurfacing/replacement at the McMann athletic facility in the amount of \$111,068.70, and the City Manager is authorized to execute the project contract and all other documentation that is necessary, appropriate or convenient to the project. The project is funded under Capital Account 05-0514-545.

Councilor Paulhus made a motion to put the item on the floor for discussion. Councilor Wyman seconded the motion.

Parks and Recreation Director Steve Balboni gave a brief overview of the project and stated that he hoped that the it would be starting around the first of next month and be a 4-6 week process.

ORDER AUTHORIZING PURCHASE

WHEREAS, the track surface at the McMann athletic facility has significantly deteriorated, and now is in need of replacement; and

WHEREAS, the only contractor in Maine specializing in the replacement and repair of track surfaces is Maine Tennis & Track of Gray, Maine; and

WHEREAS, pursuant to Section 7-110 of the Ordinances of the City of Bath, when the nature of a purchase renders the competitive bidding process ineffective by virtue of a single supplier, selection of a single supplier is authorized; and

WHEREAS, Maine Tennis & Track has a proven record of quality work, customer service, and is the City's current contractor at the McMann athletic complex; and

WHEREAS, the proposal amount for the project from Maine Tennis & Track is \$178,500.00 and is within budget; and

WHEREAS, selection of Maine Tennis & Track to perform the necessary work would be appropriate under the circumstances.

NOW, THEREFORE, BE IT ORDERED by the City Council of the City of Bath that Maine Track & Field be awarded the contract for track replacement at the McMann athletic facility in the amount of \$178,500.00, and the City Manager is authorized to execute the project contract and all other documentation that is necessary, appropriate and convenient to the project. The project is funded under Capital Account 05-0514-545.

Councilor Mitchell made a motion to put the item on the floor for discussion. Councilor Paulhus seconded the motion.

Parks and Recreation Director Steve Balboni stated this would be the second stage of the installation process and consist of the laying of the rubberized surface, painting of lines and the detail work of the rehabilitation project. He stated that the public would be made aware of times of usage availability.
