High Street West Side:

Delete: From the West Bath line to Richardson Street, no parking.

Add: From the West Bath town line to the southerly line of Lot 19-1 on Tax Map 45, no parking. From the southerly line of Lot 19-1 to the Winnegance Store Entrance, 2 hour parking. From the Winnegance Store Entrance to the driveway entrance to Lot 21 on Tax Map 45, no parking. From North of the driveway entrance to Lot 21 on Tax Map 45 to the North Line of Lot 21 on Tax Map 45, 2 hour Parking. From the North Line of Lot 21 on Tax Map 45 to Richardson Street, no parking.

High Street East Side:

Delete: From West Bath town line to Pine Street, no parking.

Add: From the West Bath town line to the Southern end of the East Side of the traffic median located between High Street and Bridge Street, no parking. From the Southern end on the East side of the traffic median between High Street and Bridge Street to the Northern end of the traffic median, 2 hour parking. From the Northern end of the East side of the traffic median to Pine Street, no parking.

Councilor Omo made a motion to put this item on the floor for discussion. Councilor Mitchell seconded the motion.

Police Chief Michael Field explained that this change was being put forth by the Parking and Transportation Committee after meetings with neighbors, business and other interested persons.

#### **Commercial Street East Side:**

Delete: From a point 170 feet North of the northerly side of Summer Street and running North 275 feet, 4 hour parking. From a point 445 feet North of the northerly side of Summer Street to Front Street, No Parking.

Add: From a point 170 feet North of the northerly side of Summer Street to Front Street, No Parking.

# 6) Order: Adopting Bath Housing Assessment and Goals Addressing Housing Revitalization

Madame Chair Eosco read the following Order:

# ORDER ADOPTING BATH HOUSING ASSESSMENT AND GOALS ADDRESSING HOUSING REVITALIZATION

WHEREAS, the Bath Housing Authority commissioned Planning Decisions, Inc. (PDI) to prepare a comprehensive study addressing the issue of housing in Bath and the Bath area; and

WHEREAS, the study focused on the history of housing and also the future of housing in the Bath market; and

WHEREAS, the study has investigated and reported on a number of demographics that inform us as to the nature of the local housing market; and

WHEREAS, the study has identified a number of unique factors regarding the local housing market including, but not limited to, such factors as the age of occupants and nature of occupancies, conditions of structures, availability of housing, and market and employment data; and

WHEREAS, the report has identified, as well, a number of advantages to living in Bath; and

WHEREAS, the study has also identified opportunities for housing revitalization in the City of Bath; and

WHEREAS, the Community Development Committee has reviewed the plan and recommends that the City Council adopt the plan as the Bath Area Housing Assessment; and

WHEREAS, a copy of the plan is available at the Bath City Clerk's Office and a copy of the Executive Summary is attached hereto; and

WHEREAS, the plan has identified eight locations that are suitable for development and would serve as housing sites; and

WHEREAS, a list of those sites, together with an aerial map showing their location, is attached hereto; and

WHEREAS, the Community Development Committee has reviewed the Bath Housing Assessment Plan in detail and has recommended that the City adopt the following goals toward plan implementation and housing revitalization:

- 1. Develop meaningful policies that aim toward rehabilitating and/or repurposing vacant foreclosures, tax acquired properties and neighborhood spot blight, in order to improve Bath's current housing stock, positively impacting neighborhood culture, and restoring taxable value on delinquent properties.
- 2. Over the next 10 years, work toward rehabilitating existing residential units, or those that could be converted to residential units, so as to meet their highest and best use. Additionally, work to encourage the expansion of natural gas and other alternative energy sources throughout neighborhoods in Bath, in order to conserve energy and reduce costs.
- 3. Apply best practices to assure that Bath's aging and disabled population can live comfortably in affordable residences, while managing maintenance burdens and safety concerns.
- 4. Strive for housing stability by identifying supply and demand needs, gauging the quality of Bath's housing stock, identifying potential development parcels, such as those outlined on page 54 (Attached) of the Bath Area Housing Assessment, and developing such parcels.
- 5. Support the construction of new residential units over the next 20 years that appropriately match the needs and restrictions of Bath's future users.
- 6. Continue to develop Bath's community brand

NOW, THEREFORE, BE IT ORDERED by the City Council of the City of Bath that the Bath Area Housing Assessment be adopted as the Bath area housing assessment for the City of Bath and that the goals and objectives for housing revitalization and implementation of the assessment, as proposed by the Bath Community Development Committee listed above, be and hereby are adopted.

Councilor Omo made a motion to put this Order on the floor for discussion. Councilor Paulhus seconded the motion.

Community Development Director Scott LaFlamme explained this Bath Area Housing Assessment document would be used for future policy goals for development in Bath and was drafted by the Bath Community Development Committee.

# 7) "Solarize Bath" Program by Community Development Director Scott LaFlamme

Mr. LaFlamme stated that the City Staff had been looking into programs that would encourage the development of alternative energies in the City. He said the focus of Staff was on a bulk purchase option of solar energy on a City-wide level. Mr. LaFlamme asked the Council to let him know if they would like City Staff to continue with this program or look into other alternatives. He then explained what the process would be for continuing with the research of this program and said the City would be working with the Town of Brunswick on the bulk purchasing of solar energy and public education regarding the program.

### L. Councilor Announcements 6:37 PM

Councilor Brackett reported that in response to the water damage to the home of Joanne Adams caused by a water main breakage last Fall, Representative Jennifer DeChant had put forth two Bills in the Legislature. The first Bill would have required home homeowners insurance or municipal insurance to cover water damage from such an incident and the second would have allowed the Water District to have a "Good Will Fund" to help in these instances. Both bills died in session. He commended the Bath Water District Superintendent Trevor Hunt, Representative DeChant, the community, contractors and plumbers for their support of Ms. Adams in her time of need.

Madame Chair Eosco reminded everyone that the Bath Heritage Days festivities would be taking place Thursday through Sunday and encouraged the public to come and enjoy all the festivities that were being offered.
