I. City Clerk White called the meeting to order at 6:00 PM.

II. City Manager Giroux gave the introduction of the Bath City Councilors.

2 year completed, commencing his third year of a 3-year term

Councilor Ward Two **Sean Paulhus**
8 years completed, commencing his second year of a 3-year term

Councilor Ward Three **Terry Nordmann**
1 year completed, commencing her second year of a 3-year term

Senior Councilor Ward Four **Bernard Wyman**
22 years completed, commencing his second year of a 3-year term

Councilor Ward Five **David Comeau**
Commencing first year of a 3-year term. Previous service: 6 years completed as Ward 5 Councilor

Councilor Ward Six **Susan Bauer**
2 years completed, commencing her third year of a 3-year term

Councilor Ward Seven **Leverett Mitchell**
4 years completed, commencing his first year of a 3-year term. Previous service: 3 years completed as At Large Councilor

Councilor At Large **James Omo**
2 years completed, commencing his second year of a 3-year term. Previous service: 6 years completed as Ward One Councilor

III. City Clerk White asked for nominations for the position of Council Chairman on the floor. Councilor Mitchell nominated Councilor Eosco. Councilor Page seconded the nomination. City Clerk White asked for any other nominations. Seeing none, City Clerk White asked Council for a show of hands in favor of Councilor Eosco. The vote was unanimous for Councilor Eosco. City Clerk White asked Councilor Eosco to take her seat as Madame Chair to serve to the first Wednesday in December 2017.

IV. Madame Chair Eosco thanked Bath voters for turning out on Election Day. Madame Chair Eosco asked for nominations for the position of Vice-Chairman of the City Council. Councilor Bauer nominated Councilor Paulhus for the position of Vice-Chairman. Councilor Nordmann seconded the nomination. Madame Chair Eosco asked for any other nominations. Seeing none, Madame Chair Eosco asked for a show of hands for Councilor Paulhus. The vote was unanimous for Councilor Paulhus. Madame Chair Eosco declared Councilor Paulhus Vice-Chairman to serve until the first Wednesday of December 2017.

Madame Chair Eosco introduced Major Jean Henderson of The Salvation Army who gave the invocation.

The Organizational Meeting concluded at 6:06 PM and the Council went directly into the Regular Meeting.
