ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BATH THAT THE LAND USE CODE OF THE CITY OF BATH ADOPTED JULY 19, 2000, AND SUBSEQUENTLY AMENDED, BE HEREBY FURTHER AMENDED AS FOLLOWS:

Amend Article 16, by adding Section 16.26, as follows:

SECTION 16.26 137 LEEMAN HIGHWAY CONTRACT ZONE District Designation

The property designated for contract rezoning is the property located on Leeman Highway, being identified as Lot 54-1, on City of Bath Tax Map 28 dated April 1, 2016.

Findings

The property is located in the Route 1 Commercial Contract Zone (C-4) Zoning District. The City Council makes the following additional findings:

- 1. Contract Rezoning is allowed in the Route 1 Commercial Contract Zone.
- 2. The project consists of a proposed 790 square foot structure situated on the 0.35 acre parcel. The proposed structure includes an Aroma Joe's coffee operation with both a drive-through and walk-up window.
- 3. Without the creation of a contract zone, the minimum yard area is 20 feet from the side, front, and rear of the parcel. Due to the size of the parcel and configuration of the site the drive through queuing lane as well as the parking area are proposed to be constructed in the yard area, necessitating contract zoning.
- 4. Contract rezoning is allowed on the parcel per section 8.10 (D) of the Land Use Code.
- 5. The project is consistent with the mandatory conditions set forth in Land Use Code Section 18.20 paragraph D, 1.
- 6. The applicant is proposing the following voluntary, discretionary conditions in exchange for Contract Rezoning. For the Contract Rezoning the applicant will:
 - Increase pedestrian and motor vehicle safety by narrowing Quimby Street and closing off multiple access points from the parcel to Leeman Highway.
 - In addition to applicable zoning requirements the applicant will incorporate enhanced streetscape elements including a sidewalk and bike rack to encourage pedestrian activity on the site.
 - Improve the appearance of the Route 1 gateway by installing decorative lighting along the Route 1 corridor to match the lighting installed along Leeman Highway.

Zoning Provision Affected

This contract zoning amendment is intended to relax the follow space and bulk standards of the Route 1 Commercial Contract Zoning District (C-4):

- 1. Minimum front setback requirement (Reduced from 50 feet to 10 feet pursuant to Section 8.10 of the Land Use Code as depicted on the Site Plan approved, with conditions, by the Bath Planning Board on July 10, 2018.)
- 2. Minimum lot line setback requirement (Reduced from 50 feet to 10 feet pursuant to Section 8.10 of the Land Use Code as depicted on the Site Plan approved, with conditions, by the Bath Planning Board on July 10, 2018
- 3. Minimum side setback requirement (Reduced from 30 feet to 10 feet pursuant to Section 8.10 of the Land Use Code as depicted on the Site Plan approved, with conditions, by the Bath Planning Board on July 10, 2018.
- 4. Minimum yard area requirement (Reduced from 20 feet to 10 feet pursuant to Section 8.10 of the Land Use Code as depicted on the Site Plan approved, with conditions, by the Bath Planning Board on July 10, 2018

Conditions of Approval

This Contract Rezoning Ordinance requires full and complete compliance with all conditions of approval, which are part of the Site Plan approval, granted to Integrity Holdings, LLC, by the Bath Planning Board on July 10, 2018, including the following conditions:

- The applicant shall complete the purchase of town-owned land to the satisfaction of the City Solicitor
- The applicant shall submit to the city planner satisfactory state approval for infrastructure improvements upon Route 1.
- The applicant shall submit for approval and install crosswalk signage to the approval of the chief of police
- The spotlight will be eliminated
- The final plans are submitted to the City Planner
- The proposed public benefits submitted by the applicant be accepted by the City Council.

Additionally, the applicant is proposing the following voluntary, discretionary conditions in exchange for approval of the Contract Rezoning. For the Contract Rezoning the applicant will:

- Increase pedestrian and motor vehicle safety by narrowing Quimby Street and closing off multiple access points from the parcel to Leeman Highway.
- In addition to applicable zoning requirements the applicant will incorporate enhanced streetscape elements including a sidewalk and bike rack to encourage pedestrian activity on the site.

RE: Request for Contract Rezoning at 137 Leeman Highway

Background

Jonathan C. DeWick, P.E, on behalf of Integrity Holdings, LLC has submitted requests for Contract Rezoning and Site Plan Amendment on the parcel located at 137 Leeman Highway (Map 28, Lot 54-1 and portion of Lot 53).

The proposed project would construct a 790 Sq foot structure along the 0.35 acre parcel. The proposed structure will consist of a drive-through coffee operation with a walk-up service window. The parcel is zoned C4.

Contract Zoning is needed for the project to meet the yard area and setback requirements. Additionally the applicant has worked with City Staff and Council to purchase a portion of the existing Right-of Way along Court Street that is included in the site plan.

The project received Site Plan approval at the Planning Board meeting held on July 10, 2018 with the following conditions:

- The applicant complete the purchase of town-owned land to the satisfaction of the City Solicitor
- That the applicant submit to the City Planner satisfactory state approval for infrastructure improvements along Route 1
- That the applicant submit for approval and install crosswalk signage to the approval of the Chief of Police
- That the spotlight be eliminated
- The that final plans be submitted to the City Planner

 That the proposed public benefits submitted by the applicant be accepted by the City Council

Additionally the Planning Board recommended review and approval of the Contract Zoning application for 137 Leeman Highway by the City Council at the Planning Board meeting held on July 10, 2018. The conditions of approval for Contract Zoning recommended at the July 10, 2018 Planning Board meeting include:

- Increase pedestrian and motor vehicle safety by narrowing Quimby Street and closing off multiple access points from the parcel to Leeman Highway.
- In addition to applicable zoning requirements the applicant will incorporate enhanced streetscape elements including a sidewalk and bike rack to encourage pedestrian activity on the site.
- Improve the appearance of the Route 1 gateway by installing decorative lighting along the Route 1 corridor to match the lighting installed along Leeman Highway.

Council Action

If the Council determines that the Contract Rezoning request has merit the council can vote to approve the request and the subsequent amendment to Article 16 (16.26) of the Land Use Code. If the Council determines that the application lacks merit action on the application will cease.



ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BATH THAT THE CODE OF THE CITY OF BATH, ADOPTED FEBRUARY 2, 1977, AND SUBSEQUENTLY AMENDED, BE FURTHER AMENDED AS FOLLOWS:

CHAPTER 8. FIRE PREVENTION

Add the following:

ARTICLE III. OUTDOOR WOOD BOILERS AND OUTDOOR FURNACES

Sec. 8-201. Prohibition of Outdoor Wood Boilers and Outdoor Furnaces.

(1) Purpose

Studies have been done indicating that outdoor furnaces and outdoor wood boilers pose environmental and health risks well beyond any public or private benefit. The smoke from these heating devices cause noxious, offensive odors and the emissions are detrimental to the public health. The purpose of this Section is to prohibit the use, construction, maintenance, or operation of outdoor furnaces and outdoor wood boilers in the City of Bath.

(2) Outdoor furnaces and outdoor wood boilers prohibited

The use, construction, maintenance, or operation of an outdoor furnace or outdoor wood boiler, other than those legally in existence and operation as of January 23, 2007, is prohibited in the City of Bath.

(3) Outdoor furnaces or outdoor wood boilers defined

"Outdoor furnace" or "outdoor wood boiler" means any equipment, device, or apparatus, or any part thereof, which is installed, affixed, or situated outdoors, for the purpose of combustion of solid fuel to produce heat or energy.

(4) Penalties

Penalties for violation of this prohibition shall be as set forth in Section 8-105.

Re: Outdoor Wood Boilers and Outdoor Furnaces

Last Spring, the City Council of the City of Bath, upon Staff recommendation, updated its Life Safety and Fire Prevention Codes by adopting the National Fire Protection Association (NFPA) #101, Life Safety Code, 2009 edition, and the National Fire Protection Association (NFPA) #1, Uniform Fire Code, 2006 edition. As part of that update, the then current Section 8-102 was deleted. This Section included the prohibition against outdoor wood boilers and outdoor furnaces, which was a separate standalone Ordinance, not part of the Life Safety Code or the Uniform Fire Code. It should not have been deleted.

Council has before it an Emergency Ordinance and a regular Ordinance which readopt the prohibition against outdoor wood boilers and outdoor furnaces.

The readoption is proposed as an Emergency Ordinance under the provisions of Section 222 of the Charter of the City of Bath. This is proposed in order that the prohibition be reinstated at the earliest possible time to prevent the establishment of outdoor furnaces and outdoor wood boilers. The prohibition of these types of devices recognizes the potential health risks from the smoke and fumes of these units and potential health issues.

In terms of process, the Emergency Ordinance contains an Emergency Preamble outlining why this Ordinance needs to be considered and passed on an emergency basis. There are a couple of nuances regarding Emergency Ordinances that Council should be aware of. First, it requires the affirmative vote of not less than six (6) Councilors for enactment. Upon enactment, it needs to be published and printed in the paper and posted in at least two public places. An Emergency Ordinance becomes effective upon its enactment but is repealed as of the 60th day following the date on which it was enacted, unless it is readopted according to normal Ordinance procedures under Section 221 of the Charter. Therefore, along with the Emergency Ordinance, is an Ordinance readopting the prohibition as it originally existed. Given first passage of the Ordinance

on September 5th and second passage at the first meeting in October, October 3rd, the Ordinance will have been adopted prior to the expiration of the 60-day period.

Re:

Outdoor wood boiler ban

On the September 5th agenda, there is an item to reinstate our ban on outdoor wood boilers. You enacted the ban in 2007, to protect properties in Bath from the impacts of these boilers. In case you're not familiar with them, an outdoor wood boiler is just what the name says. It's a boiler that is outdoors. It heats water that is then pumped into the house to use to provide heat for the house, and usually hot water. They can burn large pieces of wood, and the mess of burning wood stays out of the house. A picture of one is attached. The stacks on these are lower than the chimney on a house, and back when the ban was enacted, these units put out smoke that would hang near the ground, and impact surrounding properties negatively. Given how densely a good portion of Bath is developed, the ban was enacted.

When we updated the City code recently, to adopt new fire codes, we inadvertently deleted the outdoor wood boiler ban. We may want to revisit the ban someday, and see if new technology has made these boilers emit less smoke, and/or disperse it better than the old boilers did. To do that properly will take some time, and have to be done very thoroughly. Until and/or unless that day comes. I feel strongly that reinstating the ban is prudent.

The Public Works Department has accepted a bid proposal from Freightliner of Maine for a 2019 Freightliner Model 108SD dump truck with front and wing plow equipment. Fire chose two (2) FLIR K-2 Thermal Imaging Cameras. These cameras would be carried by firefighters when they are searching for victims and/or fires. This would be an excellent tool for dangerous incidents like those. The cost for both of the cameras is \$3,484 dollars.

Recently Fire Chief Renaud and I met with Club President Mr. Bob Warren. We presented our requests which they accepted.

Therefore, we respectfully ask the City Council to accept this gift.

We all at the Bath Police and Fire Departments thank the members of the Bath Rotary Club for these very valuable items.

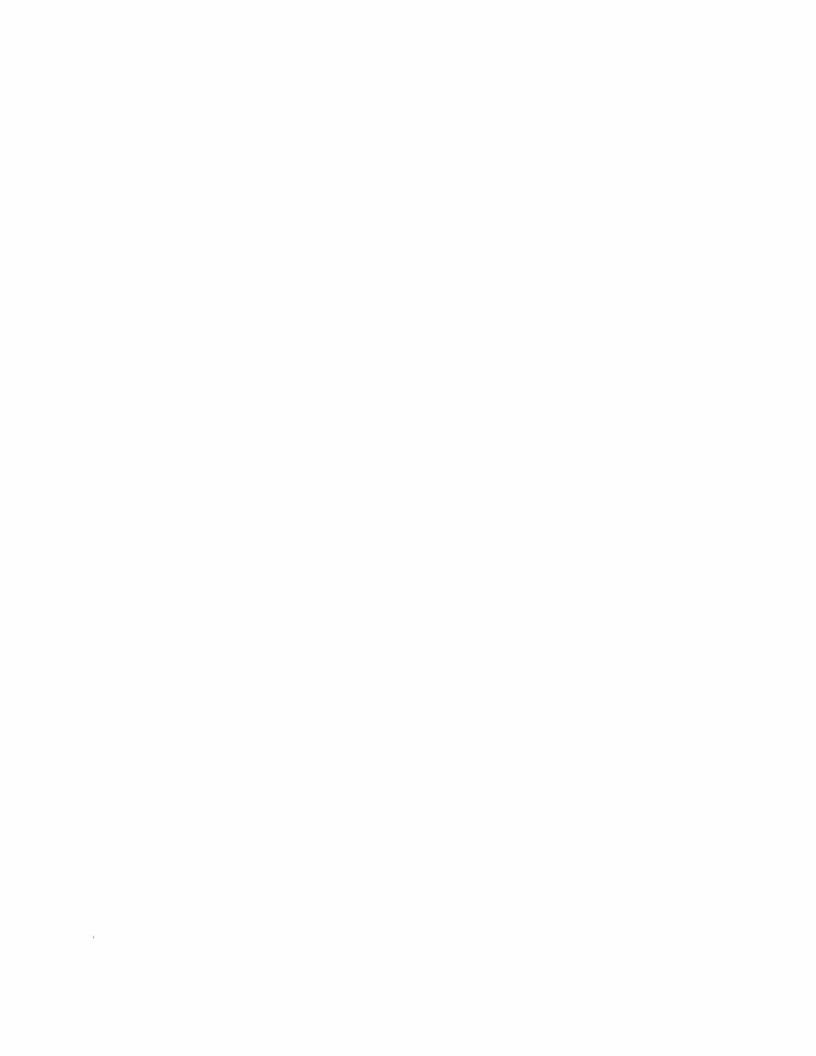

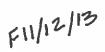

Re: TIF Budget Approval

BIW TIF Budget 2019 – The BIW TIF budget for FY 2019 is \$1,737,259. This amount has increased a bit from the prior year. Besides the debt service paid for by the TIF, Economic Development Salaries and projects and contributions to Main Street Bath, Projects being budgeted for this year include: downtown street lights, train station capital projects, Commercial Street engineering and construction, Downtown parking study, Elm Street Plaza Design, Historic Survey, Sidewalks downtown, South End Transportation Study – construction and waterfront floats.

WINGFARM TIF Budget 2019 – The WINGFARM TIF budget for FY2019 is \$119,698. The budget includes a partial payment on the street bond, and an allocation to Public Works for road maintenance. Part of the Public Works allocation will be paid the previous year's surplus.

DOWNTOWN TIF Budget 2018 – The Downtown TIF budget for FY 2019 is \$104,658 and is allocated to pay the debt service payment.

The Adoption Process

The municipal officers (i.e., selectpersons/council) adopt the local General Assistance Ordinance and yearly Appendices, even in town meeting communities. The law requires that the municipal officers adopt the ordinance and/or Appendices <u>after notice and hearing</u>. Seven days posted notice is recommended, unless local law (or practice) provides otherwise.

At the hearing, the municipal officers should:

- 1) Allow all interested members of the public an opportunity to comment on the proposed ordinance;
- 2) End public discussion, close the hearing; and
- 3) Move and vote to adopt the ordinance either in its posted form or as amended in light of public discussion.

Filing of GA Ordinance and/or Appendices

Please remember that General Assistance law requires each municipality to send DHHS a copy of its ordinance once adopted. In addition, any changes or amendments, such as new Appendices, must also be submitted to DHHS. DHHS will accept the enclosed "adoption sheet" as proof that a municipality has adopted the current GA maximums.
