Objectives

- 1. Improve pedestrain safety

- 3. Improve availability of partying / reduce parking demands.

Tom Ericho - Traffic Engineer / Consultant
Advertises expertise in complete streets.
Study bounded by Center / Webber streets.
Spent summer "collecting data for data driven effort".
Two public meetings, face to face, social media, "open ended survey".

Deliverable is report and recommendations. (Schedule?)

Current data -

Federal Functional Classification of roadways. Route 1 principle arterial. High and Washington major urban collector. Some DoT oversight / control / funding. Others are local streets. Under City of Bath Control. Noted Richardson Street a different classifications (minor collector). Discussion of Richardson Street classification.

Reviewed turning movement volumes - Washington, intersections on High St, Richardson streeet. Manual and video counting of car volume. Morning and afternoon counts both done. Question on identification of speed behaviours. Some data on speed, but not exactly same data set (done separately).

Stacked bar chart of total volume at each intersection. 1500 / 15 minutes in a.m. and 3000 / 15 minutes in p.m. (peaks). Question about 0500 shift start data? Study designed to evaluate most taxing time periods.

Question on whether study addressed type of vehicle. Information was collected in terms of vehicle type. Interest from audience, but not part of presentation.

Showed high crash incidence locations. > 8 crashes (critical rate factor) over three year period. Used 2015 - 2017.

- 1. Three way stop at Center St and High Street.
- 2. Southbound on ramp to Route 1 from High Street. Modifications to design seems to improve items.
- 3. North Bound on ramp at State Road adjacent to hotel.

Evaluation of traffic stack ups. Noted narrowing of lanes at Leeman Highway / Washington St intersection by audience.

Described foot traffic as challenging.

Speed survey. Showed 85th percentile speed as well as other items. Richardson not shown, graphed by intersection. Problem spots adjacent to Museum, and on High Street.

Pedestrian facilities documented, as well as crosswalks and conditions. Done in Northern and Southern ends. Question from resident about sidewalks at far South end of City. Ward councillor addressed. Hoping to get into far south end "at some point".

Some comments regarding substantial altercations between residents and transportation participants.
