Seymour Conservation Commission/Aquifer Protection Agency February 5, 2009 Regular Minutes

Commission Members Present: Peter Jezierny, John Hatfield, Steve Kulas, Ron Skurat, Al Cocchia, Others Present: Larry Secor, Nafis & Young Engineers, Pat Severson, Mr. Jim Severson, Tom Adamski.

The meeting was called to order by the chairman at 6:32 PM.

A **motion** was made by Mr. Skurat **Sec.** by Mr. Kulas to allow Eagle Scout Presentation be moved up on the agenda. **Motion carries with all in Favor.**

Eagle scout would like to continue a trail on the "Rock House Hill Trail" from Oxford into Seymour. Small section to be paved with processed stone. It was advised that the proposal must be presented to Inland Wetlands and Board of Selectman due to a desire to allow Cross Country running events to occur and a stream crossing. Mr. Kulas recommended that the presenters return in March for a more detailed presentation.

A motion was made by Mr. Hatfield, Sec. by Mr. Kulas to allow Mr. Secor to present. Motion carries with all in Favor.

A Level A map of Oxford Well field was presented. APA map needs to be overlaid on Town Zoning Map. Public Hearing will have to be scheduled. Followed by the adopting of map by the commission at their next meeting.

A **motion** was made by Mr. Hatfield, **Sec.** by Mr. Kulas to return to original agenda order. **Motion carries with all in Favor.**

A motion was made by Mr. Hatfield, Sec. by Mr. Skurat to accept the minutes of the regular meeting on Thursday, January 8, 2009. Motion carries with all in Favor.

Mr. Skurat made a short presentation about Greenway. Mr. Kulas is still making progress with his investigation of the boat launch.

A **motion** was made by Mr. Skurat, **Sec.** by Mr. Cocchia to send letter to Bob Looker to identify public right of way access to Housatonic River on Rt. 34.

Mr. Jezierny distributed his letter that was mailed to the State Forester with comments and suggestions.

The commission budget is to be presented in March to the Board of Finance.

The election results of the last meeting were confirmed with Mr. Pete Jeizerny remaining as Chairman, and Mr. Al Cocchia as Vice-Chairman.

The next meeting will be held on Thursday, March 5, 2009 at 6:30 P.M.

A **motion** was made by Mr. Hatfield, **Sec.** Mr. Cocchia to adjourn the meeting at 7:45p.m.
