June 5, 2008
Regular Minutes**

Commission Members Present: Peter Jezierny, John Hatfield, Ron Skurat, Steve Kulas

The meeting was called to order by the chairman at 6:30 PM.

Steve Kulas was introduced to the commission as our newest member.

A **motion** was made by Mr. Skurat, **Sec.** by Mr. Hatfield to accept the minutes of the meeting on May 1, 2008. **Motion carries 3-0 and 1 Abstention- Mr. Kulas**

Seymour Greenway Project is in Phase I, Mr. Skurat indicated that the Rt. 42 committee needs the state to be more forthcoming with information. It was noted that \$232, 00 in funds have been allocated and is being spent. Mr. Skurat want to know how it is being spent.

Boat Launch at this time has been tabled due to potential scout's lost of interest in project.

A **motion** was made by Mr. Skurat, **Sec.** by Mr. Hatfield to ask Mr. Kulas to investigate the ownership of the boat launch ram on the river side adjacent to the Lake House Restaurant. **Motion carried with all in Favor.**

Oxford- Seymour Hiking Trail- trying to link up with grant funding.

Mr. Skurat noted that 3 trucks of debris has been removed from Seymour portion of Naugatuck river.

APA Letters:

Radovich Builders- Mr. Secor will visit company to help them complete the incomplete response they submitted.

Empire Tool-Mr. Secor will visit company to help them complete the incomplete response they submitted.

Mr. Secor reported on his attendance at the Connecticut Municipal APA training program. Recommends that members of commission attend a training session if possible.

A notice of violation will be sent after no response to 3rd APA registration letters.

The commission may need to update regulations to accommodate for changes made in October 2007, Mr. Secor will review and update the commission.

2nd letters were sent to In & Out Mart and Colonial Auto Sales- with no replies, further action is necessary and is being researched for more information. Mt. Secor will work on means of compliance for next meeting.

A **motion** was made by Mr. Skurat, **Sec.** by Mr. Kulas to allow the chairman to request transfer of funds in the amount of \$3800 to parks department from account 410-1950-525-859 to Repairs & Maintenance account 450-5220-635-430 to help cover the costs of low voltage lighting in Broad Street Park, contingent on Al Yagovane presenting significant documentation of costs to the chairman of conservation and board of selectmen for approval.

Motion carries with all in Favor.

The next meeting will be held on September 4, 2008.

A **motion** was made by Mr. Kulas, **Sec.** Mr. Hatfield adjourn the meeting at 7:52 p.m.
