Mr. Smith called the meeting to order at 7:01 p.m. and led those present in the pledge to the flag.

**Discussion of Abatement Monitor Bids** 

Mr. Smith stated that after review of the six bids received for monitoring services, the consensus was that the Facilities Support Services Firm did not have the necessary materials in its resume that were required in the bidding specifications. Further analysis showed that Hygienics was the lowest bidder by an amount of \$1400. Even if an increase of PCB air tests were doubled, Hygienics would still be the low bidder.

When contacted, the Eagle Firm wanted to ensure the lab that the Hygienics Firm proposed was a legitimate and accredited one. Bill Rath, consultant, investigated this aspect and found that the firm is a legitimate and accredited one.

Mr. Smith added that this firm had also done the specifications for the underground tank installation.

Mr. Marcinek stated that one key component in hiring this firm was its cost of \$300 per test. The other firm bids were much higher in this cost factor.

Discussion of Builders Risk Insurance

Mr. Belden reported that the Town's insurance carrier, H. D. Segur had submitted a cost of \$29,330 for a one-year premium for the building project. Additional costs would probably amount to an additional \$6,000 by the end of the project. He was not sure of the definite deductible amount, but he reminded the Committee membership that it could be as high as \$5,000.
