## Discussion with Architect and Review of Presentation

Mr. Antinozzi reviewed the packet his firm had prepared for presentation at the Town Meeting scheduled for Tuesday evening, September 30, 2008, at 7:00 p.m., at the Seymour Middle School. Committee members reviewed each page and added commentary and suggested deletions when necessary. The final draft was completed and will be used as a presentation to the public who will be in attendance at the Town Meeting scheduled for September 30, 2008.

A copy of the actual referendum verbiage was shown to the Committee membership. As per bonding issue regulations, the total number of \$32, 500,000 must appear on the ballot as the total cost of the project. Some Committee members felt that this number could be misleading to the voting public who may think that this amount would be the project cost to the taxpayers. Nowhere on the ballot is the actual cost of \$12,900,000 to the taxpayers shown. It was decided that this voting procedure would have to be thoroughly explained at the Town Meeting and constantly reinforced during future presentations. Press releases should also thoroughly explain the rationale for the referendum verbiage as well as explaining what the total cost of the project will be to the taxpayers.

Mr. Antinozzi stated also that he had met during the week with Town Fire Marshal Paul Wetowitz and Scott Andrews who approved the architectural plans for the renovation project.
