Bhushan Shah is appealing the assessed value of his home located at 88 Mountain Road. He feels that the houses around him are assessed much lower than his and they have more living area than his.

Ronald Yarosh does not understand the large increase in the value of both properties he owns located at 2 Silvermine Road and 24 Silvermine Road. There is no city water or sewer and the home is not located in a scenic area-it is in the industrial park.

ACTION: Mark Thompson/Ugo Zullo to deny the appeal of the value of both properties that Mr. Yarosh owns. **Motion: 3:0**

David Ahearn: is appealing the value placed on a dump trailer he owns located at 13 Holbrook Road. Since this is a mis-appeal, this will be revisited at the next meeting held on March 20, 2008.
