The Chairman, Robert Koskelowski, called the meeting to order at 7:05pm.

Item #4 – Public Comment

MaryAnne Mascolo, Superintendent of Schools: Wants to clear up some comments from a BOS meeting. A comment regarding the BOE budget presentation and line items not discussed—the BOE budget books are handed out on February 1st and no questions of substance were asked at the meeting. A comment regarding custodial supplies are more than kids' supplies—they are required to use green products per a mandate. The textbooks line item of \$150,000 will be replacing textbooks at the end of the year, because the BOE has no contingency fund, they hold this line item for use at the end of the year and they added \$4,500 to this line item to build it up. Athletic supplies line item was \$70,000 at one time and has been cut yearly to \$39,000. The cost of EdJobs if eliminated would be \$200,000—the cost would come nowhere near that amount. There is a clear lack of understanding of the usage of the BOE money. The BOE is hiding grant money—ECS money is \$10 million of the \$30 million budget. We are happy to answer questions, but don't say we don't provide information.

Cindy Dion, 18 Carriage Drive: Listened to all the people in support of the \$1.1 million BOE budget. Has the right to vote on the entire proposed budget. Hopes we consider Mr. Ferris's offer and re-instate the full BOE budget.

Bill Sawicki requested Doug Thomas to provide a spreadsheet containing the tax revenue at a 98.01%, 98.02% and 98.03% rate for the next meeting on Tuesday March 22, 2011. Doug Thomas also asked to review all reimbursements to confirm accurate revenue.

Item #6 – Public Comment

Bill Ferris, 13 Spruce Brook Road: Has been a town resident for 30 years. He voted last year for the education and town budgets. At the past referendum vote, he thought any item for school would fail and because of this he voted against items not for school. It is nice that you added \$200,000 but wants the BOE presented budget to go to vote. If he does not see this, he will no longer vote for any town, non education items again.

MaryAnne Mascolo, Superintendent of Schools: Does not think the BOF is acting fair and equal. The town received a 3% when the BOE received a 0% last year. Would like you to consider putting out the presented BOE budget as it was.

Bruce Baker, 68 Greenwood Circle: (Board of Education Member) 1 mill is an arbitrary number and disappointed to hear the BOE will get the difference. It is nice to get more, but not enough.

Kristen Harmeling, 27 Patrick Drive: (Board of Finance Member) The BOE receiving close to its level services budget is not enough. There is no fluff in the budget and all items are necessary. Wants more for her kids than a level services budget.

Michelle Walsh, 126 Pearl Street: (Board of Finance Member) Regarding the BOE budget and why she voted for a \$500,000 increase over last year; she asked questions of substance at the BOE budget presentation regarding the use of the \$513,000 EdJobs grant. Asking specifically about what the plan would be for the next year. No plan was provided by the BOE and feels the use of the one-time grant to create new jobs is irresponsible. If the \$513,000 is used for existing salaries and add the \$500,000 increase, the BOE would receive an overall increase of over \$1 million—more than their level services budget.

Cindy Dion, 18 Carriage Drive: The BOE must use the EdJobs grant for certain things. Questions why Mr. Ferris's money cannot be used. With media and technology, everyone knows how you voted. Asks for an opportunity to vote on proposed BOE budget.

MaryAnne Mascolo, Superintendent of Schools: Budget is irresponsible? We are professionals and it is unnecessary to make this comment. Has not seen any BOF members at the BOE meetings.

Bill Sawicki, 13 Lantern Drive: Thinks education did not get enough money. If there is revenue he has no objection to saying it could go up.

Frank Loda, 27 Osprey Drive: Town Council gave an opinion at the BOS meeting regarding Mr. Ferris's donation. Suggests the BOF ask counsel provide in writing where her opinion came from.

Bob Koskelowski, Chairman Board of Finance: Would not need the BOF if we put all the requested budgets out to vote. The \$5,000 cost of a referendum vote never entered his mind. He cares as much about education as all other budgets, we do not have the extra. Michelle Walsh did ask questions regarding the EdJobs grant and now we are hearing the money cannot be used to retain jobs. It was explained at the BOE budget presentation, unemployment would cost about \$5,000 per person for 39 weeks totaling over \$150,000. He would not be bitter to not vote in other areas because he did not get what he wanted. Please do not be bitter if we disagree and be courteous to others.

Bill Brown, 24 Dauria Lane: Let the people vote.

Jay Hatfield, 25 Patton Ave: He is an educator, went to Seymour schools and has seen some of the sacrifices. He does not want to see another 0% increase to the BOE.
