Item #11—Discussion and Take Possible Action on Blight Ordinance Revision

Attorney Fred Stanek was present to answer questions regarding the Blight Ordinance revisions. The Board of Selectmen had a lengthy discussion regarding concerns voiced by residents at the Public Hearing on July 16, 2013 at 6:30pm.

Attorney Stanek recommended having another Public Hearing regarding the Blight Ordinance Revisions if they were not filed with the Town Clerk's Office. Concerns regarding the fourteen day compliance window and the \$100 per day fine were discussed. The Selectmen debated compliance windows from the stated 14 days to 21 days to 30 days. Possibilities of setting up avenues to help residents were discussed.

The Board of Selectmen discussed the allowance of the Blight Officer onto private property if invited by a resident to inspect an adjacent property that is felt to be blight but is not viewable from the road. Language regarding house gutters and disabled individuals needs to be revised. The Board of Selectmen will continue discussion on the Blight Ordinance Revision for action at the August 6, 2013 Regular Meeting.

Item #18—Public Comment

Frank Connors, 26 Union Street: Blight complaints should be provided on a form and people should not be allowed to make anonymous complaints. What dictates who can make a blight complaint?

Jamie Brennan, 124 Bungay Road: His 250 year old home never had gutters and does not agree that not having gutters is considered blight. Does not agree with site lines visible from complaining person's property. A tax payer has the right to their own property.

Al Yagovane, 25 Elaine Drive: Broad Street Park had the last brick installed today on the main walkway. Grass cannot be planted until September.

Sean Walsh, 126 Pearl Street: The current Blight Ordinance covers all of the complaints that were made today. The town cannot dictate how much firewood is too much. Agrees the time frame is too short and the gutter dilemma is covered by removing the word "missing" from the ordinance. In agreement with Theresa Conroy and thinks the sign the Blight Officer has posted on properties looks tacky and ridiculous. Blight can happen overnight when the ordinance is abused with complaints on boats and bicycles. Wording is needed to restrict repeat complaints on a property that has been deemed not blighted by the officer and maybe a penalty is needed for continual false complaints. The town has an obligation to protect all residents, even if you don't like how it looks.

Mike Flynn, 85 Skokorat Street: The police are needed to stop speeding on Skokorat. The town may want to look into dehydrated foods in the unfortunate fate of a catastrophic event.

Item #19—Selectmen's Public Comments

Karen Stanek: A big proponent of the Blight Ordinance and would like to see it enforced at TriTown Plaza. Would like to see the trash at Gary Park picked up either before the kids arrive or after the kids leave for Summer Camp. Dennis Rozum stated trash would be picked up prior to kids arriving for camp. Asked if commission would be paid on the sale of LoPresti School; Kurt Miller stated "no".

Nicole Klarides-Ditria: Congratulations to the Seymour All Stars moving onto Regionals.

Al Bruno: Glad to hear all the public comments.

Gary Bruce: Would like to see the Check Register included in the correspondence. Kurt Miller stated he would have it included with every packet. Thanks to Al Yagovane for a job well done at Broad Street Park.

Kurt Miller: Over the last couple of meetings the Board of Selectmen have done a lot of good for the town. He is proud to sit with the six of them.
