ITEM # 11 - Proclamation for "Donate Life Connecticut Month".

WHEREAS, one of the most meaningful gifts a human being can bestow on another is the 'gift of life' through organ and tissue donation;

WHEREAS, more than 110,000 men, women and children wait for a life-saving organ transplants, of which over 1,200 reside in Connecticut;

WHEREAS, the need for organ and tissue donation grows daily as a new patient is added to the waiting list for an organ transplant every 11 minutes;

WHEREAS, the critical donor shortage remains a public health crisis as an average of 19 Americans die daily due to a the lack of available organs;

WHEREAS, a single individual's donation of the heart, lungs, liver, kidneys, pancreas and small intestine can save up to eight lives, donation of tissues and eyes can save and enhance the lives of more than 50 others;

WHEREAS, over one million Connecticut residents have registered their decision with the Connecticut DMV Organ and Tissue Donor Registry to ensure their wishes to be organ and tissue donors are honored;

WHEREAS, Connecticut residents can designate their wishes to be a donor when applying for or renewing their driver's licenses or ID cards or registering online at www.DonateLifeNewEngland.org;

WHEREAS, this observance pays tribute to organ and tissue donors and their families whose decision to Donate Life enables others to receive life-saving organs and tissues for transplant;

NOW, THEREFORE, BE IT RESOLVED that in recognition of National Donate Life Month, the Month of April is hereby proclaimed "DONATE LIFE CONNECTICUT MONTH" in the Town of Seymour and in doing so we encourage all Connecticut residents to say "YES" to donation to Save Lives.

ITEM # 14 - Discussion with WPCA concerning financial matters.

John Fanotto, Chairman WPCA and other members and employees: Explain the financial status of the WPCA. Explains that operations are funded completely by user fees, impact fees, and money from the State and CL&P. The WPCA has the same fiscal year as the Town, but bills in April and October. States that there have been no increases in fees in 11 years and there has actually been a decrease. The WPCA financials are filed with the minutes every month for viewing. There has been a significant decrease in funding from outside sources and the WPCA are going to have to increase their fees this year. They have also submitted a capital project list, along with explaining all of the maintenance that needs to be done, which includes replacing and fixing aging piping, repairs to the plant and replacing the belt press, as well as several other projects that need to be done. The WPCA will have their budget available in May or June for viewing. They invite anyone that would like to tour the plant and/or come to one of their meetings if they have any further questions or concerns. John Conroy: Explains that the debt service on sewer projects is ending within the next couple of years and would like to know if there are any additional projects that will need to be bonded for so the Town can add them to their 5-Year Capital Plan. Mr. Fanotto states that there are some projects that they would like to bond, but are not completely sure on the costs at this time. He states that the Brook Street area will need to be done and the ballpark figure is approximately \$450,000.00. He will make sure that the plans are submitted to the Town when they are completed.

RESOLUTION IN SUPPORT OF CONTINUED FUNDING FOR COMMUNITY SERVICES BLOCK GRANTS

WHEREAS, TEAM Inc. provides critical social services to needy families and individuals in the lower Naugatuck Valley region, and WHEREAS, the municipalities of the lower Naugatuck Valley region lack the resources to staff individual or regional social service departments, and

WHEREAS, TEAM Inc. competently fulfills this need and responsibly manages its resources, and

WHEREAS, TEAM Inc.'s appropriation of Community Services Block Grant (CSBG) funding permits it to meet this regional need, and

WHEREAS, TEAM Inc. is one of twelve community action agencies in Connecticut which serves all 169 towns and cities, and uses CSBG funds to manage and develop regional social services, and

WHEREAS, the President has proposed a 50% reduction in Community Services Block Grant (CSBG) funding nationwide, including a cut of more than \$4.2 million to Connecticut;

NOW, THEREFORE BE IT RESOLVED, that the Town of Seymour urges the President Barack Obama and the United States Congress to preserve the federal Community Services Block Grant at the current funding level as it is critical for the continuation of valuable services for needy families in the region, specifically: Meals on Wheels, Head Start, School Readiness, Volunteer Income Tax Assistance, Energy Assistance, Eviction Prevention, Child Day Care, and Asset Development.
