ITEM # 4 - First Selectman's Report.

- VCOG meeting to discuss their budget, dues raised to \$10,014.00. Last 4 years \$9,537.00. Brownfield due the same at \$800.00.
- Met with Kip Lockhart, union representative to introduce himself and set up time to start union contract negotiations.
- Met with Dave Elder of VCOG, DOT, Milone McBroom, on Route 67 project. Stressed that money be spent on actual work and less on study.
- Met with new Commission on Aging to set up their commission. New commissioners ask the Senior Center Director questions to get a feel for the way the Senior Center is run.
- Met with Waterbury Development Corp. and Shelton EDC & VCOG to discuss strategies for projects to be considered. These would be projects in Seymour that the Local EDC would be promoting.
- Attended roundtable discussion at Bungay School concerning transitioning pre-schoolers to K-3. Board of Education Chairman Ed Strumello and I attended as did about 25 others involved with these children.
- Attended Marine Corps. League ceremony honoring the Raising of the Flag on Iwo Jima, many other dignitaries and vets attended.

ITEM # 5 - Public Comment.

Richard Rossik, 34 Robert Street: Upset about the condition of Robert Street. States that the prior administration did armor coating and cold patch and the road is like Swiss cheese. He would like the Board to consider funding more road repairs.

Frank Loda, 27 Osprey Drive: Recalls the FOI case concerning the rules for videotaping meetings. Is aware that a new set of rules have been drawn up and would like to give the Board members suggestions taken from FOI for 2 additional rules that should be added to the official document.

ITEM # 6 - Discussion with COST representative Barton Russell, Executive with the Board of Finance.

COST's Executive Director Barton Russell: The Town of Seymour have been members of COST since 2001. Mr. Russell has brought a packet of information on what COST offers to the Town of Seymour and other small towns in the state. Explains that COST is responsible for creating the STEAP Grant and Town Aid Road, which the Town of Seymour has been able to take advantage of in the past and present. COST was established in 1976 and is instrumental in lobbying for the small towns.

Board of Selectmen and Board of Finance members ask questions concerning legislative services, the Chatfield LoPresti School Project, and the contrast between COST and CCM.

ITEM # 7 - Report from Superintendent concerning high school swimming pool incident.

The Superintendents Office has provided an Incident Report, which includes chronological events of the pool contamination incident that began on 12/23/10. Present are Superintendent Maryanne Mascolo, Assistant Superintendent Richard Belden, Director of Facilities Wayne Natzel, and Chairman of the Board of Education Ed Strumello. The incident report was reviewed and several questions were asked. The cleanup costs are approximately \$35,000. The incident report also included details on the corrective action that was taken. A copy of the Incident Report is available on the Town of Seymour website.
