Resolution of the Seymour Board of Selectmen Opposing the Closing of the Derby Courthouse

WHEREAS, the Town of Seymour is served by the Derby Courthouse located at 106 Elizabeth Street in Derby, which provides convenient and efficient access to the Judicial Branch of the State of Connecticut for the residents and officials of the Town of Seymour; and

WHEREAS, the Governor's Revised 2009 Budget Proposal calls for the closing of the Derby Courthouse; and

WHEREAS, the closing of the Derby Courthouse would adversely affect the residents of the Town of Seymour in that officials of the Town of Seymour, such as police officers, who need to conduct business with the Court will need to travel longer distances and therefore expend additional time outside of the Town of Seymour causing further expenditures from the Town of Seymour's Budget; and

WHEREAS, residents of the Town of Seymour are employed by the Judicial Branch at the Derby Courthouse and therefore their jobs may be in jeopardy; and

WHEREAS, the presence of the Derby Courthouse in the Valley is beneficial to the economy of the area.

NOW THEREFORE, BE IT RESOLVED that the Board of Selectmen of the Town of Seymour vigorously opposes the closing of the Derby Courthouse and urges Governor Jodi Rell and members of the Connecticut General Assembly to take all actions necessary to cause the Derby Courthouse to remain open for the benefit of the Town of Seymour and its residents and for all of the people of the Lower Naugatuck Valley.
