## First Selectman's Report:

- Roberta King will not be attending tonight's meeting due to being under the weather.
- The Annual Seymour Memorial Day Parade will be held on Sunday, May 24, 2009 at 11:30AM. The parade route will be reversed this year and will begin at French Memorial Park and end at the Seymour Community Center. At 11:00AM opening ceremonies will start. The bandstand will remain at the Train Station. All Selectmen are welcome to attend.
- A big thank you goes out to Comcast and all of the volunteers for "Comcast Cares Day", Saturday, April 25, 2009 at French Memorial Park. The park was cleaned, painted, raked, and repaired. Comcast provided breakfast and lunch for all of the volunteers. The First Selectman and Selectman Paul Roy were among the volunteers. The whole event was a success.
- On Sunday, May 17, 2009 beginning at 8:00AM there will be a cleanup effort by volunteers in the Downtown area, which was organized by the Downtown Merchants Association. They will be sprucing up the whole area.
- The Seymour Pride Committee is scheduling several cleanup efforts around Town. These are volunteer only events and anyone is welcome to help. It is a great effort to take pride in our Town.

### **Public Comment:**

Fire Chief Scott Andrews, 23 Bissell Place: Is at the meeting with Assistant Fire Chief Tom Tomasheski to discuss the fact that there have been several incidents where there have had to be rescues below the falls of the Naugatuck River due to many teenagers and other people swimming there. This is dangerous for everyone, the swimmers and fire personnel. This is State owned property. The Fire Department is requesting that the First Selectman and the Board of Selectmen request permission from the State to post "No Swimming" signs along the bank at the falls and the surrounding area. This is for the safety and welfare of everyone involved. The signs will also give the Police Department authority to take action against violators.

The First Selectman will contact the State and request that "No Swimming" signs be put up in the area of the falls and along the banks of the Naugatuck River.

ITEM # 1 - Request for new telephone lines at 20 Pine Street by the Fire Marshal. (Take action)

The Fire Marshal had submitted a proposal at the April 7, 2009 Board of Selectmen meeting to install new phone lines at the Community Center for the fire alarm system. Those quotes were too high so he was asked to come back with other prices if possible. He has obtained a substantially lower quote for the phones from AT&T. Installation approximately \$205.00 and approximately \$300.00 per year.

The First Selectman spoke to a representative from the State concerning the permit and was told that the Town would receive it within 7 to 10 days.

Paul Roy: Has some questions and concerns regarding the issues on Emergency Transfers that have been brought up lately. He would like the process clarified for his own interest.

Robert J. Koskelowski: Knew that he would be asked these questions tonight so he contacted Doug Gillette, the Town's Bonding Counsel, who is very knowledgeable on the Town of Seymour Charter and State Law. He provided a 2 ½ page legal opinion on this issue, which the First Selectman did not want to get due to the legal expense that he felt was unnecessary because the Charter is clear. He will provide the Board members with a copy in their next agenda packets. The legal opinion states that it is the conclusion of Attorney Gillette "that emergency appropriations do not constitute supplemental appropriations and therefore do not require approval from the Board of Finance (or the Town Meeting)."

Robert J. Koskelowski: States that there was a bad situation at the newly opened Trestle Tavern on Saturday night. There were some police officers injured and many arrests made. There is some rowdy clientele and the Town may require the owner to hire a police officer. They have been reported to the Liquor Commission for the incident.
