- Town Counsel, George Temple responded that we are due to go to trial in the month of April. The position of the owner is that the property is worthless. Currently there is someone interested in the property which is relevant in that proceeding.
- The First Selectman responded that the Fire Marshal and the Building Inspector have been contacted to view property tomorrow to see what needs to be done. There is a contract on the table at this time with a large commercial firm and will be leasing property for storage for about six months and hope to be in by April 1st. The Economic Director, John Criscuolo has worked very hard to bring someone into this property.
