Mr. Strumello asked if we will be replacing this position and Mrs. Syriac confirmed that we will be posting it after this meeting.

## 4. Introduction of Officer Shook – Christine Syriac

Mrs. Syriac introduced Officer Meredith Shook who has been on the job in our schools for three weeks. She continues to keep Mrs. Syriac updated weekly on her activities. Mrs. Syriac said she has only heard wonderful reports and she is doing a good job building relationships with students, staff and parents. Mr. Stanek said the Board and the district are very happy to have her on board. Mr. Strumello asked when she would be receiving her SRO training and Officer Shook said it would take place during this summer.

## 5. All-Hazards School Security and Safety Plan – Nancy Snopkowski, Rich Kearns

Mrs. Syriac briefly spoke about the mandated All Hazards School Security and Safety Plan that is supposed to be in place by July 1, 2014. She pointed out that we are ahead of many districts because of the work that Mr. Kearns has done in his capacity as Director of Security. This program involves a tremendous amount of work. She introduced Mr. Kearns who briefly described the program which requires the standardization of emergency response across the country. He said it contains different plans for different scenarios. He reported that our plan is up to date. All staff will be required to take a NIMS course which will be available online. All staff is required to take three hours of training which will be done during the summer months. Mr. Kearns also spoke about the requirement that each school have their own plan and have a safety committee in each school. This has already been done. Mrs. Syriac said the actual plan will be brought forward to the Board to vote on at the June BOE meeting. She said there is a price tag associated with the implementation of the program due to the extensive training required. There is a requirement to have security assessments every two years. Ms. Magri asked if there would be ongoing education and Mr. Kearns said there was not requirement for it as of yet. Mr. Strumello voiced a concern for offsite sporting events and asked if coaches would be trained. Mr. Kearns confirmed anyone employed by the district would be required to take the training, including volunteer and substitutes.

#### 6. College Readiness Day – Glenn Lungarini

Mr. Lungarini spoke about the possibility of having a College Readiness Day where the SAT would be offered to our seniors. He spoke about having SAT school day testing which would lower the cost for students to take the test. Substantial savings can be realized. In addition, he said he felt it might open the door to more students taking the test. He said it might encourage more students to continue their education. Currently grade 9 students take Read Step on that day, and grade 10 and grade 11 students take the PSAT.

### COMMUNITY RELATIONS & COMMUNICATIONS ADVISORY COMMITTEE

The Committee shall concern itself with developing and implementing communication programs to facilitate meaningful and relevant communication between the Board and community members, leading to greater collaboration, open discussion, and transparency in the District.

## Committee makeup:

- Three board members (3),
- One parent representative from each school (4), with the PTA/PTO from any school that has such an organization nominating that individual and any school that does not have such organization having a parent representative appointed by the school administration.
- The most recently appointed teacher of the year or their his or her designee (1).
- One community member at large (1), recommended by the Superintendent or Board of Education Board of Selectman
- Two members of the Seymour Schools administration (2), recommended by the Superintendent
- Member of the Board of Selectman (addition)
- Member of the Board of Finance (addition)
   13 MEMBERS

The Chairman of the Committee will be a Board member, elected by the full Committee. Recommendations shall be submitted to the Board of Education for approval in the month of September. The Committee shall meet no fewer than four times each year, with additional or regular meeting schedules established as the Committee sees fit.

#### J. Middle School Audit

Mr. Belden briefly went through the process that occurs during a building process saying an estimate is submitted, the building committee is formed, the plan is closed and then an audit is done to be certain the estimate was correct. He said no bonding is necessary because it is only \$10,000 and the project is closed. The funds go to the town. He said it is not unusual to find small things. There was not a negative impact on the grant. This does not impact the taxpayers. He also noted that the High School building project is being audited now. Mrs. Syriac pointed out that this was outstanding on the town side and the person who deserves the credit is Mr. Belden who assisted the town above and beyond the scope of his normal job. Mr. Belden said by working through the Middle school audit he is better prepared for the next audit.

She said she believed all but one member of the Board of Finance agreed with this number.
