Further, the Board directs the administration to offer the student an alternative education opportunity pursuant to Connecticut General Statues Section 10-233d(d) for the period of this expulsion.

The Board also directs the administration, pursuant to Connecticut General Statues Section 10-233d(f), to record this expulsion on the student's cumulative education record, to be expunded from such record if the student graduates from high school.

Finally, the Board authorizes Yashu Putorti and Attorney Dan Murphy to communicate in writing the Board's decision and the reasons therefore, consistent with the Board's executive session discussion, to the student and his/her parent(s).
