Mr. Baker reported on a meeting he attended at Chatfield ready to answer questions on the progress of the Chatfield addition with about 20 people in attendance; architects and others involved in the building addition attended, but only one parent came. The parent had several complaints such as too much noise during school hours and to much dust on campus. Mr. Baker expressed his disappointment on the parental attendance because many professional people came to answer their questions about the Chatfield addition Mr. Baker also toured the high school to look at the possibility of the BOE being moved to Seymour High School. Discussion followed on several options possibly available to relocate the BOE to, i.e. LoPresti School, Seymour High School, the Seymour Community Center. Mr. Stanek passed out an article entitled "Flunking Civics – Why America's Kids Know So Little" for BOE members' perusal. Mr. Kubik reported crews are working 10 hours a day, 6 days a week on the Chatfield addition.

Ms. Mascolo reviewed the details of her report, including meetings and activities of the last two weeks, upcoming meetings and events. Ms. Mascolo announced Harvey Catlin, 8th grade teacher at Seymour Middle School, was selected as Teacher of the Year. She also reported the middle school passing will be at 10:00 a.m. and the high school graduation will begin at 6:00 p.m., both being held on Wednesday, June 15th.

Mr. Stanek announced Dr. George Tzepos is the recipient of this year's Distinguished Alumni Award. Dr. Tzepos is a 1985 graduate of Seymour High School, has an Optometry practice in Seymour, and owns Zois Pizza. He and his family reside in Bethany.
