#### **INFORMATION**

A. Student Representative Report

- Fred Stanek asked the board to reconsider the \$180 parking fee for students at the High School. Mr. Stanek would like to put this on a future Board meeting agenda. Mr. Stanek believes that the prices need to be lowered based on concerns he has heard from students and parents. The finance committee will meet to discuss the financial implications of lowering the fee and then the decision and findings will be brought to the entire board for discussion. Rick Belden was asked to secure the financial information for the finance committee. MaryAnne Mascolo will schedule the finance committee meeting.
