09-E32 MOTION: (Mrs. Loda, sec., Mrs. Yitts) Move that pursuant to Connecticut General Statutes Section 10-233d(g) the Seymour Board of Education shall adopt the expulsion decision of the Norwalk Board of Education and expel the student discussed in executive session from attendance at Seymour High School for the period of October 13, 2009 until the beginning of the third quarter of the 2009-2010 school year for the reasons presented by the administration in this hearing.

The Board finds that the conduct that was the basis of the expulsion of the student by the Norwalk Board of Education also warrants expulsion under the policies of the Seymour Board of Education. The student shall be offer an alternative educational opportunity during any period of expulsion.

The Board further directs the administration, pursuant to Connecticut General Statutes Section 10-233d(f), to record this expulsion on the student's cumulative educational record, to be expunged from such record if the student graduates from high school.

Finally the Board authorized Bruce Baker and Attorney Daniel P. Murphy to communicate in writing the Board's decision and the reasons therefore, consistent with the Board's executive session discussion to the student and/or his or her parents as appropriate.
