VI. INFORMATION AND REPORTS:

A. Student Representative Report

Joe told Board Members that the Junior Prom is May 16th. Joe said with the small class sizes next year the juniors and seniors will probably have a combined prom. Joe told Board Members the Take A Stand day is scheduled for May 15, 2009.

Allie told Board Members that AP testing has begun – May 4th and will end on May 15th. The National Honor Society banquet will be held next Wednesday, May 14, 2009. The National Honor Society will induct several new members.

B. The Link Crew program – Seymour High School – Sandy Labacz

Sandy Labacz, Freshman Counselor at Seymour High School, made a short presentation to Board Members about a new mentoring program for incoming freshman at Seymour High School. As one of the Link Crew Coordinators, Sandy explained that the new program will help freshman feel more connected to Seymour High School. The Link Crew Coordinators with the help of about 40 pre-selected junior and seniors, known as group leaders, will go through a series of activities during orientation with the incoming freshmen. During the school year the group leaders will check in on their freshman to see how things are going. Through the use of this program Ms. Labacz hopes to create a positive environment for the freshman at the High School.

C. School Improvement Plan Progress – Cathy Goodrich – Seymour High School

Mr. Freund with the help of Mr. Lucke presented to Board Members the summary of how Seymour High School progressed through the 2008-2009 school year. Mr. Freund said that in the following areas Science, Math and Reading the departments created CFAs that were based on goals in a certain area that each department felt needed to improve. The pre-assessment was administered to students in the fall of 2008 and the results were charted to see the students' strengths and weaknesses. The post assessment was administered in the spring of 2009 and again the results were charted. There was improvement in some areas and the assessments also showed areas where more professional development with the staff was needed. Mrs. Goodrich said things are progressing nicely at Seymour High School and they are on track and will be in good shape for the next site visit from the NEASC committee in 2015.

The FEMA Student Tips Emergency Planning (STEP Program) video was shown for Board Members' information. Students from Bungay School's fourth Grade, Mr. Cummings, their teacher and Mrs. Feige, the Principal were all featured in the video.
