Further, the Board directs the administration to offer an alternative educational opportunity to the student for the period of this expulsion, pursuant to Connecticut General Statutes Section 10-233d(d) as determined by a PPT convened by Oxford.

The Board further directs the administration, pursuant to Connecticut General Statutes Section 10-233d(f), to record this expulsion on the student's cumulative educational record, to be expunged from such record if the student graduates from high school.

Finally the Board authorized Jim Ward and Attorney Frederick L. Dorsey to communicate in writing to the student and his parents as appropriate, the Boards decision and the reasons therefore, consistent with the Boards' executive session discussion
