Ms. Mascolo suggested if Board Members decided that parking fees prices had to be raised – raise it to \$50 then go to \$100 next year.

Ms. Mascolo invited Board Members to opening day ceremonies for teachers at Seymour Middle School on Monday, August 25, 2008 at 8:00 a.m. Teacher of the Year, Mary Deming, will be one of the speakers.
