Chief's Attending: Tom Tomasheski, Steve Childs, Jim Smith, Dale Cann

Meeting called to order at 7:28 pm, followed by the Pledge of Allegiance.

Motion made to accept April Meeting Minutes by Asst. Chief Childs, 2nd by Asst. Chief Smith. Approved 3-0. (Asst. Chief Cann was not present at this time)

Correspondence:

- Chief Tomasheski discussed a letter from CT Transit regarding their purchase of hybrid buses.

Chief's Report:

Health:

- Asst. Chief Cann stated that he gave a list of physicals to the Captains.

Training:

- Asst. Chief Smith stated that Super Sunday make up was held on April 27, 2011 at Citizens. Super Sunday is scheduled for May 24th at 7:00 at Great Hill.
- Take A Stand Day is scheduled for May 6th at 10:00a.m.
- Asst. Chief Childs came up with ten names for the dive team class.
- The FF1 program was cancelled for lack of enrollment.
- Asst. Chief Smith stated that they are looking for burn dates. May 15th, June 12th, June 19th and June 26th are open right now.
- The basic meter classes are scheduled for May 24th & 25th.

Maintenance:

Citizens:

- Rescue 12 – Medical bag OOS, 02 bottles not back. New Hurst unit installed.
- Engine 13 is still leaking fluid, has to go back out for repair. Nozzle for booster line is broke, driver's side backup light is out, and the batter charging indicator is being worked on by Comm. Services.
- The Citizens Engines Knox boxes are programmed.
- Chief Tomasheski stated that he needs phone numbers for all air cards.
- The batteries for the portables are in.
- No hydraulics on Truck 14. At Tracys for repair.
- Lightbar doesn't work on Hazmat 7.


