- Two quotes handed in for damage that was sustained to Asst. Chief Smith's Chiefs Vehicle on August 23rd on Hickory Lane. One quote was from Gabby's for \$2,666.48 and the second quote was from Sabo's for \$2,627.41. **Motion made to have Sabo's repair the vehicle for \$2,627.41 by Asst. Chief Tomasheski, 2nd by Asst. Chief Cann.**

- Firefighter Kennedy from Citizens interested in taking the Fire Service Instructor Class and was inquiring about reimbursement. Chief Andrews said the cost needs to be paid by the individual upfront and once successful completion of the class, money can be reimbursed.
- Citizens Fire Police Captain George Decker said safety vests need to be purchased. He would like four for each company at \$65.00 a piece.
- Chief Andrews mentioned a lot of money is being spent on broken and missing items. He reminded Officers that equipment needs to be taken care of and asked them to remind their members.
- Mike Fritz looking for reimbursement for eight storage containers he purchased for the dive equipment. The reimbursement is for \$126.95.


Executive Session:






