Fire Marshal's Report:

January Fire Marshal's Report was read. There was no representative from the Fire Marshal's Office present at the meeting.

• Chairman Atkas asked Chief Smith about the "clerk's overload" statement in the Fire Marshal's report. Chief Smith will talk to the Clerk about this.

February Chief's Minutes:

Discussion:

- Commissioner Sampiere asked what the house system at Great Hill was. Commissioner Motasky explained that it is a speaker system.
- Commissioner Motasky asked about the roof at Tri-Town Plaza being unsafe. He asked if they can go inside the building just not on the roof. Chief Smith will find out.

Old Business:

- Commissioner Motasky stated that an Engineer was assigned to do a walk through at Great Hill on Wednesday for a recommendation on the roof.
- Commissioner Jurgens stated that the washing machine is almost in.
- Chief Smith attended the budget hearing, had a meeting with the First Selectman and will attend the finance meeting tomorrow night.

New Business:

• Commissioner Motasky stated that the Past Chief's Dinner is scheduled for April 13, 2013.

Motion made to purchase a plaque for Past Chief Tomasheski not to exceed \$150.00 by Commissioner Motasky, 2nd by Commissioner Sampiere. Approved 4-0 (Commissioner Andrews not present at this time)

• Emergency Management Director, Tom Eighmie requested having access to the Officer's room at Great Hill because the internet router is in there. Valley Health was told they can temporarily use one the downstairs' office.

Motion made to not give Emergency Management Director, Tom Eighmie access to the officers' office at Great Hill reason being if an EOC is open, an Officer or Chief will at the EOC by Commissioner Sampiere, 2nd by Commissioner Motasky. Approved 4-0 (Commissioner Andrews not present at this time)

• Commissioner Motasky stated that he believes there should be 1 Chief and 4 Assistant Chiefs that hold a term longer than 1 year. He also feels they should have meetings like the Commissioners where they have to vote on issues. Chief Smith stated that the Chiefs run their meetings the same way. Commissioner Jurgens sees no reason to change it. Discussion followed.

- Commissioner Andrews feels that the Chiefs should have more than 2 one year terms.
- Chairman Atkas agrees on the idea for new terms for the Chiefs. He suggested the Chiefs and Officers get together and discuss this.
- Chief Smith has insurance report for inspection from January.
- Asst. Chief Lombardi stated the new rescue truck is here.
- Chairman Atkas has the tax abatements.

SEYMOUR FIRE MARSHAL'S REPORT SUMMARY OF OFFICE ACTIVITIES FOR JANUARY 2013

Below is a brief summary of the major work activities that the Seymour Fire Marshal's Office conducted during the month of January 2013:

Building Inspections – The Office conducted 2 inspections on new construction, 7 inspections on existing buildings and 7 re-inspections.

Blasting Site Inspection -0

Other Complaints – 1

Alarms – The number of fire department incidents for December is unknown. Due to the clerk's workload, the report is not ready for this month.

Major Activities

Roosevelt Drive, 1747 Restaurant and Tavern – The final inspections have been completed. This building now has a complete certificate of occupancy. This project is completed.

172 North Street, shopping center – There has been no change since last month. The Office is monitoring any future progress. The building is partially occupied.

39 New Haven Road, Seybridge Plaza – There has been no change since last month. The Office is monitoring the construction progress for a two story small addition behind the Fitness Center.

396 North Main Street, the old Valley Garage – There has been no change since last month. The Office ismonitoring the Code upgrade progress on this building.

Outside Training Attended-None

University of New Haven Intern – The intern has completed her activities in the Office. She has been given a completion letter from the Office. She did a great job and significantly assisted in the Office. She will be missed.

42 Silvermine Road, Thule Company – Another inspection was conducted on the office renovation. They are nearing the completion of the project.

600 Derby Avenue, Haynes Quarry - Blasting activities at this site has begun again.

West Church Street at Ryder Avenue, Aquarion Water Pump Station – This project includes the upgrading of this pump station. We are monitoring the construction activities and have begun answering questions from the contractors.

Safety Coordinator Activities – I continued to work on reactivating the A.E.D. program that is thru Griffin Hospital Parish Nurse Program. This involved 4 buildings and training town employees. This required a lot of leg work.

School Security - The Office continued work on the review of the schools with the committee. The intent is to ensure that any modifications do not violate the fire code. DFM Willis continues to head this activity for the Office. Many departments are involved.

29 Maple Street, old Anna Lopresti School – We had to deal with a sprinkler system leak due to the cold. This took considerable time due to many issues.

167 Main Street, Knights of Columbus – The Office is working on dealing with potential Code issues if the Church that rents out the space for ceremonies increases its number of children for religious education.

Significant Fire Investigations: 6 Colony Road Extension – At this time, this appears to be an accidental house

fire. The point of origin is in the living room. However, due to the amount of fire damage in the living room, the cause is undetermined.

42 R Smith Street – This is an accidental garage fire. The point of origin is around the wood stove and/or masonry chimney. The cause is combustibles being either too close or inadequate clearance reduction methods.
