**Strand Report;** Theater manager, Geri Swinik, not in attendance, report given by Treasurer Priscilla Altorelli - September 2013 \$2,500 in tickets \$1,556.00 in concessions = **\$4,056.00**. Mrs. Altorelli reported that a letter had been sent to First Selectman Miller by the Knights of Columbus Building Committee, stating that since a new lease had not been agreed upon and good faith negotiations were not proceeding as the Knights would like, they were raising the rent to \$1,700.00 per month effective as of October 1, 2013. All other terms and conditions of the lease as written will be abided by until a new lease has been agreed upon. The Commission will not enter into any contracts with outside parties until the lease has been agreed upon.

**Concert Series 2014;** The Commission has decided due to low attendance on the 3<sup>rd</sup> Saturday summer concerts, this event will be canceled for the 2014 series. Concerts will begin the First Saturday in May 2014 and continue with a concert/block dance on only the First Saturdays of June, July, August and September, 2014. It was also decided that times of the concerts would be changed to 7-9 pm. (see schedule)

October, December, February, March and May the Naugatuck Community Orchestra will perform with seasonal selections with free concerts; (see schedule).

Mary Barbin had been in touch with the Callahan House and scheduled a December 5, 2013 performance for them by DD Magic. Another performance will be scheduled for them in the summer of 2014.

**Grants:** Kim Osgood has been working with the school system to schedule assemblies with the elementary school principals from the Valley Foundation Grant we received. Assemblies will be on Reading for younger students and Bullying for upper grades.

Katherine Matthies Grant was received and will be used to reimburse our line-item for concerts for the 2013 Concert Series. Grant paid for both concerts by Flashback.

**New Business:** Priscilla Altorelli motioned that we continue to hold our monthly meeting on the second Tuesday of the month, 7:00 pm through December 2014. Second made by Valerie D'Anna **VOTE: 4 YES 0 NO 0 ABSTAIN** Mrs. Altorelli will submit schedule to First Selectman's Office.

Members were asked to be at the Strand Theater for the Trick or Treat Day by 12:15 pm on the 26<sup>th</sup>.
