Ms. Dee Caruso, from Seymour Town Hall, spoke to the members of the Commission in regards to a recent problem that had come up on the Strand Theater's Facebook page. It seems that someone had posted very inappropriate remarks regarding the theater and she was advising the members that any and all posts must go through the First Selectman's Office. Ms. Caruso was informed by Chairman Simpson that no one from our Commission has access to the Facebook page and felt that the entries came from theater employees. Ms. Caruso will be reporting to Mr. Miller and a letter will be sent to the theater employees regarding any further posts on the Strand's website.

Ms Caruso reported to the Commission that Grants will be submitted for us to both the Matthies Foundation and the Valley Community Foundation. These grants will request coverage for Concert Bands and entertainment to be provided to the schools in Seymour.

It was also discussed that Town Hall had received inquiries to why the old movies stopped being shown at the Strand? She was told that we would pass the question on to the theater manager.

Lion's Club Yvonne Loinez, Lion's Club President requested that Culture and Arts work with them to bring a child's author to town. They are interested in having a book signing, a story hour and a book swap. It was decided that the event would be held at the Strand Theater on Sunday, May 19, 2013 from 2-4 PM. Author Anthony Paolucci, will sign books and read to the children.

Melissa Poynton-Smith, Lion's Club member also told the Commission that they would hold a Car Show on both the first "First Saturday" in June and September. Both concerts on those dates will be given by Flashback.

Section 10.25

There shall be a Culture and Arts Commission consisting of seven (7) members whose terms will be two (2) years and will be Administrative Appointments of the First Selectman. This Commission shall be responsible for providing both affordable and no-cost entertainment for the residents of the Town of Seymour, and shall have oversight of the Strand Theater.
