<u>Public Comment-</u> Brian Zullo walked the theater and reported that the back stage area was very full and would need to be cleaned out before his performance. He also questioned the condition of the stage and the need to be painted. He was instructed to contact Megan Tarby, who the Commission believes plans to paint or at least has the paint for the job to be done.

Chairman Simpson discussed with Mr. Zullo that the Commission will see what happens with the first performance before we commit to the additional 2 shows that have been discussed. Mr. Zullo was in full agreement. Ticket prices will be \$25.00 per person with the Restoration Fund receiving \$2.00 per ticket. He will need entrance to the theater at 5:00 pm Mon-Fri of tech week. Shows will be July 19, 20, 21, 26, 27 & 28. Geri will sell refreshments and Brian will get a liquor permit for beer and wine to be sold during show.

Linda Bellavance will write letter to First Selectman Miller requesting alcohol usage at the theater.

Shows will start at 7:00 pm. "Broadway at the Strand" will appear on Channel 8 and 4.

## **Strand Theater Report: None**

<u>Chairman's Report:</u> Judy Simpson announced that we would be working with the members of the American Legion for a Christmas Tree Lighting on the First Saturday in December. Both Boy and Girl Scout Troops will be asked to make decorations for the birds to be placed on the tree.

Chairman Simpson asked that the Stars Wars Trilogy purchased by the Commission be loaned to the Walnut Hill Church Youth Group for viewing.

Mary Barbin will try to arrange for the Naugatuck Valley Symphony be booked for a Sept. 29, 2012 and December 15, 2012 concerts at the Strand. Movie themes and holiday music will be played.

It was reported to the Commission that Walnut Hill Church will have to spend \$8,000.00 - \$10,000.00 to bring the Knights of Columbus Hall up to code for weekly usage.
