<u>Public Comment-</u> Brian Zullo, presented plans to the Board regarding bringing 3 Broadway Plays to the Strand - those included - July 2012 The Full Monty October 2012 – The Rocky Horror Show and December 2012 Smokey Joe's Café. Each show would be held over for 2 weekends. Brian explained that 1 full dress rehearsal would be open to the senior population from the area nursing homes and local Senior Centers for free. The Commission will discuss dates and arrangements. Production Co. will have own insurance.

Meghan Tarby, Looking Glass Productions, reviewed schedule for rehearsals and try-out regarding the children's performance scheduled for June 1 & 2, 2012 with a 7:00 pm (Fri) performance and a 1:00 PM (Sat) performance. The Burlesque Show scheduled for June 29, 30 and July 1, 2012 (Fri) 8:00 pm, (Sat) 8:00 pm and (Sun) 6:00 pm.

She has arranged for Antonio's to do the after party one evening and Trestle Tavern another evening, she is still looking for a third restaurant to handle the food for the third showing. Food and drink will be served in the Knights Hall.

Meghan will also be painting the theater stage. Jeri Swinik, theater manager, complained that the bare areas are reflecting on the screen when movies are playing

Chairman Simpson will discuss finance arrangements with him regarding the percentage given to the Theater's renovation Fund. 10% per ticket will be requested rather than a flat rental cost. The first presentation's results will dictate how we distribute funds for the second presentation. Brian will be invited to next meeting to discuss further details and schedules.

<u>Old Business:</u> Jeri Swinik reported to the Commission that the right side of the theaters' stage curtain had been ripped was in need of repair. She will contact Mr. Peterson, to see if he can come in and resew ripped area.

Mary Barbin will be getting information from a Seymour resident who performs with an area Symphony Orchestra who would like to perform in the Theater. Possibly a December, 2012 performance would be arranged.
