Guest Speakers: Commission members were given a presentation by Mr. Charlie Corrente and Paul Sarybrat regarding their participation in the Star Wars Marathon Weekend planned for May 14, 2011. They will provide costumed Star Wars characters to attend the movie marathon, posing for pictures, interacting with movie goers and walking Main Street before the event. A dozen or so characters will be present through-out the day. Ticket prices for the three movies will be decided at a later date. Flyers and press releases will distributed to get as much publicity as possible. All proceeds from Marathon Weekend will go towards the renovation fund for the Strand Theater.

If the May marathon weekend is a success the final 3 Star Wars movies will be shown in October, 2011.

Mrs. Swinik also reported that a projector lamp has been replaced and possibly a reflector will be needed soon.

She will also design a flyer for the 2011 Block Dance series to be dropped off at town businesses and town buildings.
